WHEREAS, the recognition was granted to the institution namely S.B.G. Sanskrit Mission B.Ed College, Bazar Street, Mutharasanallur, Trichy-620101, Tamilnadu run S.B.G. Sanskrit Mission Trichy District-620101, Tamilnadu vide SRC order No. F.SRO/NCTE/B.Ed/2006-2007/9184 dt. 13.11.2006 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2006-2007.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 16.02.2015. A revised provisional recognition order was issued to the institution on 27.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 320th meeting held on 19th to 20th September, 2016 considered the matter and decided to issue Show Cause Notice. As per the decision of SRC, a Show Cause Notice was issue to the institution on 15.10.2016. The institution submitted reply on 03.07.2017.
- 4. AND WHEREAS, The SRC in its 346th meeting held on 24th to 25th October, 2017 considered the matter and decided to issue Show Cause Notice. As per the decision of SRC, a Show Cause Notice was issue to the institution on 31.10.2017 The institution submitted reply on 27.11.2017.
- 5. AND WHEREAS, the SRC in its 381st meeting held on 31st October-01st November 2019 Committee decided to issue Final Show Couse Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 07.09.2020. The institution has not submitted any reply against Final Show Cause Notice.
- **6. AND WHEREAS,** the matter was further considered by the SRC in its 395th meeting held on February 25-26, 2021 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

1 The Committee noted that due to non-compliance of Email dated 15.10.2016 for submission of requisite documents to verify infrastructure & instructional facilities a Final Show Cause Notice dated 07.09.2020 was issued to the institution. However the institution failed to submit the requisite documents as per Final Show Notice dated 07.09.2020.

Hence, the Committee decided to withdraw the recognition granted to S.B.G. Sanskrit Mission B.Ed College, Bazar Street, Mutharasanallur, Trichy-620101, Tamilnadu for conducting B.Ed course with effect from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to S.B.G. Sanskrit Mission B.Ed. College, Bazar Street, Mutharasanallur, Trichy-620101, Tamilnadu run by S.B.G. Sanskrit Mission Trichy District-620101, Tamilnadu for conducting B.Ed. course of two years duration with an annual intake of 100 students (2 units) w.e.f. the next academic session i.e. 2021-2022 onwards.
- 8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
