WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely **SRP College of Education, Near NH - 7, Muthukali Patty P.O., Rasipuram Taluk, Namakkal District - 637401, TamilNadu** run **SRP Educational Trust; Muthukali Patty P.O., Rasipuram Taluk, Namakkal District - 637401, Tamil Nadu** vide SRC order No.F.TN/SEC/SRO/NCTE/2005-2006/5133 dt. 06.01.2006 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2005-2006.

2. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 22.01.2015. A revised provisional recognition order was issued to the institution on 30.04.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

3. **AND WHEREAS**, the SRC in its 369th meeting held on 28.01.2019 has considered the matter and the Committee decided to issue a Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on **03.05.2019**. The institution has not submitted any reply in respect of Show Cause Notice.

4. **AND WHEREAS**, the SRC in its 384th meeting held on 12th - 13th February 2020 and the Committee decided to issue a Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on **10.08.2020**. The institution has not submitted any reply till date.

5. **AND WHEREAS**, the SRC in its 388th meeting held on 14th-15th September 2020 considered the matter and the Committee decided to issue a last Reminder letter. Accordingly, a last Reminder letter was issued to the institution on 21.09.2020. The institution has not submitted its reply to the last Reminder letter till date.

6. **AND WHEREAS**, the matter was further considered by the SRC in its 395th meeting held on February 25-26, 2021 and the Committee decided as follows: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

1. The Committee noted that due to non-compliance of SCN dated **03.05.2019** for submission of requisite documents to verify infrastructure & instructional facilities a Final Show Cause Notice dated **10.08.2020** was issued to the institution. However the institution failed to submit the requisite documents as per Final Show Notice dated **10.08.2020**.
2. Further the SRC also given the last opportunity for submission of written representation/reply by way of last Reminder letter dated 21.09.2020 and the institution failed to submit the reply to the last reminder letter.

Hence, the Committee decided to **withdraw the recognition** granted to **SRP College of Education, Near NH – 7, Muthukali Patty P.O., Rasipuram Taluk, Namakkal District – 637401, Tamil Nadu** for conducting **B.Ed** course with effect from the next academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

7. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **SRP College of Education, Near NH – 7, Muthukali Patty P.O., Rasipuram Taluk, Namakkal District – 637401, Tamil Nadu** run by **SRP Educational Trust, Muthukali Patty P.O., Rasipuram Taluk, Namakkal District – 637401, Tamil Nadu** for conducting **B.Ed. course** of two years duration with an annual intake of 100 students (2 units) w.e.f. the next academic session i.e. 2021-2022 onwards.

8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
