CONTINUATION ORDER

WHEREAS, recognition u/s14 (3)(a) of NCTE Act, 1993 was granted to the institution namely **Palamoor Education, Survey No. 463, 464, Amistapur Village, Bhoothpur (M), Mahabubnagar, Taluk and City, Mahabubnagar District – 509382, Telangana** for offering B. Ed course for two years duration for the academic year 2016-17 under section 14/15 of the NCTE Act, 1993 to the Southern Regional Committee, NCTE through online on 29.06.2015. The institution has submitted the hard copy of the application on 17.07.2015.

2. **AND WHEREAS**, the matter was placed before SRC in its 295th Meeting held on 28th-30th November & 01st December, 2015 and the committee considered the matter and decided that the inspection of the institution was fixed between 10-30 days after receiving this letter. The same was intimated to the institution on 16.01.2016. Accordingly, the inspection of the institution was conducted on 22.02.2016. The institution has submitted documents along with the VT report.

3. **AND WHEREAS**, the SRC in its 305th meeting held on 25th-27th February 2016, considered the matter and decided to issue LOI to the institution. Accordingly, as per the decision of SRC, LOI was issued on 25.02.2016. The institute submitted its reply along with documents on 12.04.2016.

4. **AND WHEREAS**, the SRC in its 309th meeting held on 12th to 14th April, 2016 considered the matter and decided to issue Formal Recognition order to the institution. Accordingly, as per the decision of SRC, Formal Recognition order was issued on 02.05.2016.

5. **AND WHEREAS**, the SRC in its 314th meeting held on 27th to 28th May, 2016, considered the matter and decided to **Request for change of name is accepted**. Thereafter, for the request of the institution a Corrigendum order was issued to the institution vide order no. F.SRO/NCTE/SRCAPP14623/B.Ed./TS/2016-2017/87207 dt. 12.07.2016 instead of words as "Palamoor Education" to "Palamoor College of Education".

6. **AND WHEREAS**, a letter received from Smt. Ranjeev R. Acharya, I.A.S, Special Chief Secretary to Govt. Education Department, of Telangana vide D. O. Letter No. 5380/SE.Trig/A2/2016-2, received on 07.11.2017.

7. **AND WHEREAS**, the SRC in its 347th meeting held on 16th & 17th November, 2017 considered that matter and decided to issue Show Cause Notice to the institution. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 28.11.2017 and a letter also sent to the Special Chief Secretary to Government on 08.12.2017. The institution has submitted show cause notice reply on 05.02.2018. Reply from Chief Secretary to Government not received.

8. **AND WHEREAS**, the SRC in its 360th meeting held on 23rd – 24th May, 2018 considered the matter and decided to issue a letter to the institution. Accordingly, as per the decision of SRC, a letter was issued on 25.05.2018. The institution has submitted a written representation on 19.07.2018.

9. **AND WHEREAS**, the SRC in its 406th Meeting held on 19th January, 2022 considered the matter and decided to conduct an inspection of the institution. Accordingly, as per decision of SRC a letter was issued to the institution on 04.02.2022. The inspection of the institution was conducted on 28.04.2022 and the Visiting Report was received in the office on 09.05.2022.

10. **AND WHEREAS**, the SRC in its 411th Meeting held on 23rd & 24th May, 2022 considered the matter and decided to give an opportunity to the institution before issuing the withdrawal order. Accordingly, a letter was issued on 04.06.2022. The institution submitted its reply on 30.05.2024.

11. **AND WHEREAS**, the SRC in its 438th meeting held on 03rd June, 2024 considered the matter and decided as under: -

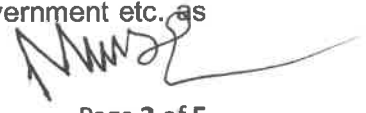
“The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

The Committee on the perusal of the reply submitted by the institution, decided that the **continuation order** be issued to the Institution **Palamoor College of Education, Survey No. 463, 464, Amistapur Village, Bhoothpur (M), Mahabubnagar, Taluk and City, Mahabubnagar District – 509382, Telangana** for B.Ed. programme for 2 basic units of 50 students each.”

12. **NOW THEREFORE**, this order is issued permitting the institution i.e. **Palamoor College of Education, Survey No. 463, 464, Amistapur Village, Bhoothpur (M), Mahabubnagar, Taluk and City, Mahabubnagar District – 509382, Telangana** for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (2 basic units of 50 students each) subject to fulfillment of the following conditions: -

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

13. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.



14. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

15. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities; such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it sodesires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

16. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

17. The institution shall make available the list of students admitted on its official website.

18. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
