#### ORDER

WHEREAS, the institution namely Mangalam College of Education, S.No.489/2, No.9-343, Bhavani Main Road, Mangalam Nagar, Anthiyur-638501, Erode District, Tamilnadu was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2005-2006/5332 dt.03.02.2006 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2005-2006.

AND WHEREAS, the Tamilnadu Teachers Education University had forwarded a copy of show cause notice issued to the institution for not functioning in accordance with the conditions stipulated by the NCTE, SRC, Bangalore and Tamilnadu Teachers Education University as could be apprehended from the report of Inspection commission which caused a surprise visit to the colleges.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 31.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

AND WHEREAS, provisional revised recognition order was issued to the institution on 14.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the matter was placed before in 314th meeting of SRC held on 27th & 28<sup>th</sup> May, 2016 wherein a general decision was taken to cause inspection of such cases. Accordingly, as per the decision of SRC, a letter for inspection was sent on 27.06.2016 and the inspection was conducted on 13.01.2016.

AND WHEREAS, the matter was placed before the SRC in its 351st meeting held on 28th - 29<sup>th</sup> December, 2017 as the following ground:

- 1. This is a RPRO case for B.Ed. (2 units) & M.Ed. (1 unit).
- 2. They have given a Faculty list. It is faulty.
  - i) Assistant Professor (Econ) Ms. Damayanti is only a second class (i.e., 50%) post graduate and is therefore not qualified.
  - ii) Assistant Professor (Tamil) Ms. Asripa Begum also is only a second class (i.e. 50%) post graduate and is therefore not qualified.
  - iii) Assistant Professor (English) Mr. R. Natarajan also has only a second class (i.e., 50%) PG Degree and is, therefore, not qualified.
  - iv) Assistant Orif (Mr. Jagadeeswaran) has a M.Sc. (Computer Science) PG degree which can not be accepted unless the Regulation is amended.
  - v) The Principal's Service certificate is not given.
- 3. When the Faculty list is received after rectification, put up along with all the linked cases to enable composite verification of adequacy of land area, built-up area, faculty lists, etc.

AND WHEREAS, as per the decision of SRC, a letter was issued to the institution on 19.01.2018. The matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

Accordingly, as per the decision a Show Cause Notice was issued to the institution on 26.03.2019 (M.Ed.). The institution submitted its reply along with documents dt.07.10.2020.

AND WHEREAS, the matter was placed before the SRC in its 389<sup>th</sup> meeting held on 12<sup>th</sup> & 14<sup>th</sup> October, 2020 considered and decided as the following grounds:

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

On the perusal of the reply submitted by the institution vide letter dt 24.08.2020 & 03.06.2020, the Committee decided that the continuation order be issued to the Institution Mangalam College of Education, No.9-343, Bhavani Main Road, Mangalam Nagar, Anthiyur-638501, Erode District, Tamilnadu for the following courses:-

- (i) B.Ed 2 units (50 students each unit).
- (ii) M.Ed-1 unit of 50 students."

NOW THEREFORE, this order is issued permitting the institution i.e. Mangalam College of Education, S.No.489/2, No.9-343, Bhavani Main Road, Mangalam Nagar, Anthiyur-638501, Erode District, Tamilnadu for continuation of recognition for B.Ed. programme for 2 units (50 students each unit) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 1. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc as applicable.
- 2. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 3. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;

- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 4. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 5. The institution shall make available the list of students admitted on its official website.
- 6. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
