The Institution shall submit revalidated FDR's of the enhanced values, in joint account with the SRC before 30 june, 2015 failing which the recognition will be withdrawn. II. Further, with regard to the second unit the institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015. III.
