WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Mahatma Gandhi Teacher Training Institute, 8/68, North Street, Solaiseri, Reddiarpatti, Tirunelveli District, Tamilnadu-627753 run by Sri K. Ramachandra Naidu Memorial Educational Trust, Tirunelveli District, Tamilnadu for conducting Elementary course & D.T.Ed. course as per following details: -

- (i) Vide order no. F.TN/ELE/SRO/NCTE/2004-2005/1521 dt. 22.06.2005 for conducting Elementary course of two-years duration from the academic session 2005-2006 with an annual intake of 50 students.
- (ii) Vide order No. F.SRO/NCTE/D.T.Ed.-AI/2006-2007/8351 dt. 06.10.2006 for Elementary (D.T.Ed.) course of two years duration from the academic session 2006-2007 with an annual intake of 100 students which includes the existing intake of 50 students and an additional intake of 50.
- 2. AND WHEREAS, the institution has submitted a written representation through email on 01.03.2023 as under: -

"I beg to submit the following for your kind consideration.

We were running Mahatma Gandhi Teacher Training Institute 2 units from 2005-2006. Due to poor admissions, we stopped the intake of students from 2018-2019. Admissions have not been made thereafter. Hence, I request you to withdraw the recognition of our institute and release the FDRs worth of Rs 16 Lakhs. Kindly do the needful."

3. AND WHEREAS, the SRC in its 422nd Meeting held on 02nd & 03rd March, 2023 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the Institution vide letter dated 01.03.2023 by withdrawing the recognition granted to Mahatma Gandhi Teacher Training Institute, 8/68, North Street, Solaiseri, Reddiarpatti-627753, Tirunelveli District, Tamilnadu for conducting D.T.Ed. & D.T.Ed-Al Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC."

4. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to Mahatma Gandhi Teacher Training Institute 8/68, North Street, Solaiseri, कार्यात्रय: जी-7, सेक्टर-10, Office: G-7 Sector-10,

Reddiarpatti-627753, Tirunelveli District, Tamilnadu run by Sri K. Ramachandra Naidu Memorial Educational Trust, Tirunelveli District, Tamilnadu-627753 for conducting annual intake of 50 students for Elementary course and for conducting D.T.Ed. programme of two years duration for additional intake of 50 students with effect from end of the academic session i.e., 2022-2023.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

 या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान
 करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमित प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम
 या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार,
 किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज
 या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")
- 6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
