CONTINUATION ORDER

WHEREAS, recognition was granted to the institution namely, **Sathyasai B.Ed. College, Thiruvallur, Paruthipet Village, Avadi Town, No.7, Rajaji Street, Poonamallee Taluk, paruthipet City, Thiruvallur District-600071, TamilNadu** vide order no. F.No.SRC/NCTE/SRCAPP201630219/M.Ed./1Unit/362nd Meeting/2018/97913,14,15,16,17, 18 dt. 29.08.2018 for conducting M.Ed. Course of two years duration with an annual intake of 50 students (1 Unit) from the academic session 2019-2020.

2. **AND WHEREAS**, the SRC in its 404th meeting held on 16th – 17th November, 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 30.11.2021. The institution has submitted reply on 08.12.2021.

3. **AND WHEREAS**, the SRC in its 406th Meeting held on 19th January, 2021 has considered the matter and decided to withdraw the recognition. Accordingly, as per decision of SRC a Withdrawal Order no. F.SRO/NCTE/SRCAPP201630219/M.Ed/TN/2022/130155 dated 04.02.2022 was issued to the institution.

4. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-39/E-240290/2022 Appeal/11th Mtg.-2022 dated 11.01.2023 appeal remand back the order appealed against. The institution vide letter dated 09.02.2023 submitted reply to the appeal remand back order.

5. **AND WHEREAS**, the SRC in its 421st Meeting held on 10th February, 2023 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the **continuation order** be issued to the Institution **Sathyasai B.Ed. College, Survey No. 716/16, 716/19A, 716/20, 716/3A, 716/16A2, 716/20A & 716/4, Paruthipattu Village, Poonamalle Taluk, Thiruvallur District, TamilNadu-600071** for M.Ed. programme for 50 students. subject to the condition on submission of an Affidavit on Rs.100/- Non Judicial Stamp paper clearly mentioning the name and account number of each of the faculty appointed for M.Ed. programme and also stating therein that the faculty are being paid salary through cheque/RTGS/NEFT. The Affidavit should be supported with documents like photocopy of passbook of each of faculty showing the disbursement of salary through bank account to individual faculty members (at-least for 3 months). After receipt of the same the RD, SRC is advised to issue continuation order only after obtaining the above required documents and place before the Committee for ratification.

6. **AND WHEREAS**, as per decision of SRC a letter was issued to the institution on 17.02.2023. The institution has submitted bank statement vide letter dated 21.02.2023 according, to statement the salary is being disbursed through bank.

7. **NOW THEREFORE**, this order is issued permitting the institution i.e., **Sathyasai B.Ed. College, Survey No. 716/16, 716/19A, 716/20, 716/3A, 716/16A2, 716/20A & 716/4, Paruthipattu Village, Poonamalle Taluk, Thiruvallur District, TamilNadu-600071** for Continuation of recognition for **M.Ed. programme** for two years duration with an annual intake of **1 basic unit of 50 students** subject to fulfilment of the following conditions: -

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

8. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

9. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

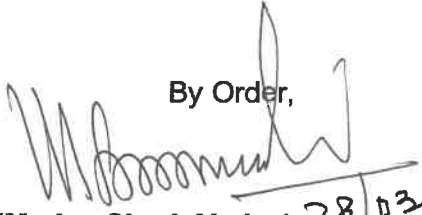
- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.



- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
11. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
12. The institution shall make available the list of students admitted on its official website.
13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
