WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely District Institute for Education and Training, Neredmet, Ramakrishnapuram Post, Secunderabad, Andhra Pradesh (Now Telangana) for conducting Elementary course as per following details: -

- (i) Vide order no. F./SRO/NCTE/97-98/5092 dt. 09.02.1998 for conducting Elementary course with duration of two years for the year 1998-99.
- (ii) Vide order No. F.AP/ELE/SRO/NCTE/2004-2005/6968 dt. 07.09.2004 for conducting Elementary course of one year duration from the academic session 2004-2005 with additional intake of 20 for Telugu Pandit, thus making the annual intake of 100 for Telugu Pandit course and 50 for Urdu Pandit course.
- 2. AND WHEREAS, the Southern Regional Committee (SRC) in its 413th Meeting held on 22nd & 23rd August, 2022 discussed the matter about the institutions who failed to submit the PAR as advised by the NCTE and directed to the Regional Director, SRC to serve a Show Cause Notice to failure of submitting the PAR to all such inspections seeking infrastructure and instructional details along with GIS location at the earliest. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 01.11.2022. The institution has submitted its reply 14.11.2022.
- 3. AND WHEREAS, the SRC in its 425th Meeting held on 18th May, 2023 has considered the reply and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision of SRC Final Show Cause Notice was issued to the institution on 30.05.2023. The institution did not submit any reply to the Final Show Cause Notice.
- 4. AND WHEREAS, the SRC in its 426th Meeting held on 23rd June, 2023 has considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

(i) The institution failed to submit reply to the Final Show Cause Notice (FSCN) dated 30.05.2023.

Hence, the recognition granted to **District Institute of Education and Training, Neredmet, Hyderabad Dt., Secunderabad, Telangana-500056** for **Elementary Course (D.El.Ed) course** is withdrawn under Section 17(1) of NCTE Act, 1993. No fresh admissions are permitted now onwards. However, if any student is pursuing **Elementary Course (D.El.Ed.) programme** is allowed to continue till they complete the course. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body shall also be withdrawn."

- 5. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws the recognition granted to District Institute of Education and Training, Neredmet, Hyderabad Dt., Secunderabad, Telangana-500056 for conducting D.El.Ed programme of two years duration with duration an annual intake of 100 students for Telugu Pandit course and 50 for Urdu Pandit course. No fresh admissions are permitted now onwards. However, if any student is pursuing D.El.Ed. programme is allowed to continue till they complete the course.
- 6. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

(6. इसके अलावा, संस्था और संबद्ध निकाय को एनसीटीई अधिनियम की धारा 17(4) के निम्नलिखित प्रावधानों के बारे में सूचित किया जाता है: -

"यदि कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमति प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

- 7. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
