WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Parimala Teacher Training Institute, No. 504, Main Road, Kovilpatti, Tuticorin District, Tamilnadu-628502 run by Sri K. Ramachandra Naidu Memorial Educational Trust, Tuticoring District, Tamilnadu vide order no. F.SRO/NCTE/D.T.Ed./2006-2007/9705 dt. 23.12.2006 for Elementary (D.T.Ed.) course of two years duration with an annual intake of 50 (Fifty) students.

2. AND WHEREAS, the institution has submitted a written representation dt. 13.09.2019 as under: -

"I beg to submit the following for your kind consideration and favourable action.

I wish to submit that since admissions are very poor we do not make any admission to the program. We would like to close it.

Hence, I request you to return the Original Deposit Receipts bearing the numbers 33824403613 dated 07.05.2014 for Rs. 5 Lakhs and 33803774659 dated 26.04.2014 for Rs. 3 Lakhs drawn at State Bank of India, Rajapalayam and help us to closure of the FDR Accounts."

3. AND WHEREAS, the SRC in its 422nd Meeting held on 02nd & 03rd March, 2023 has considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the Institution vide letter dated 13.09.2019 by withdrawing the recognition granted to Parimala Teacher Training Institute, No. 504, Main Road, Kovilpatti, Tuticorin District-628502, Tamilnadu for conducting D.T.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC."

4. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to Parimala Teacher Training Institute, No. 504, Main Road, Kovilpatti, Tuticorin District-628502, Tamilnadu run by Sri K. Ramachandra Naidu

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."
