WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Immaculate College of Education for Women, Pakkamudayanpet, Pondicherry-605008 vide SRC (NCTE) order no. F/SRO/NCTE/1999-2000/1089 dt. 24.09.1999 to Secondary course of duration of one year with an intake-60.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 29.01.2015 for its willingness and adherence of provisions of new Regulations. Thereafter, a revised provisional recognition order was issued to the institution on 28.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.
- **3. AND WHEREAS,** the matter was placed in its 317<sup>th</sup> meeting of SRC held on 28<sup>th</sup> & 30<sup>th</sup> July, 2016 has considered the matter and decided to constitute VT. Accordingly, as per the decision of SRC, inspection of the institution was conducted on 01.09.2016 and the VT report was received on 07.09.2016.
- **4. AND WHEREAS**, the SRC in its 381<sup>st</sup> Meeting held on 31<sup>st</sup> Oct & 01<sup>st</sup> Nov, 2019 and 387<sup>th</sup> Meeting held on 24<sup>th</sup> & 25<sup>th</sup> August, 2020 considered the matter and decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 10.09.2022. The institution did not submit reply to Show Cause Notice.
- **5. AND WHEREAS,** the SRC in its 397<sup>th</sup> Meeting held on 25<sup>th</sup> & 26<sup>th</sup> March, 2021 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of the SRC a Final Show Cause Notice was issued to the institution on 12.04.2021. The institution did not submit reply to Final Show Cause Notice.
- **6. AND WHEREAS,** the institution has submitted information regarding Performance Appraisal Report (PAR) dt. 19.07.2022.
- **7. AND WHEREAS,** a letter was received from Pondicherry University dt. 03.09.2020 regarding Continuation of Provisional Affiliation for the academic year 2020-2021.
- **8. AND WHEREAS,** the institution has filled the PAR for the academic session 2020-2021 in compliance of public notice dt. 29.09.2021 issued by NCTE HQ.
- **9. AND WHEREAS,** the SRC in its 413<sup>th</sup> meeting held on 22<sup>nd</sup> & 23<sup>rd</sup> August, 2022 took note about the institution who have filled the PAR with certain deficiencies. In view of the decision, the Regional Committee advised the Regional Director, SRC to issue SCN to all such institution seeking infrastructure and instructional details along with GIS location at the earliest. Accordingly, as per

decision of the SRC Show Cause Notice was issued to the institution on 15.09.2022. The institution has submitted its reply vide letter dt. 01.02.2023.

- 10. AND WHEREAS, the SRC in its 422<sup>nd</sup> Meeting held on 02<sup>nd</sup> & 03<sup>rd</sup> March 2023 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issue to the institution on 05.04.2023. The institution has submitted its reply vide letter dated 28.03.2023 uploaded decision in the website.
- 11. AND WHEREAS, the SRC in its 423<sup>rd</sup> meeting held on 12<sup>th</sup> April, 2023 considered the matter and Committee decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Immaculate College of Education for Women, Re-survey No. 244/1A, Pakkamudayanpet, Oulgaret Municipality, Pondicherry-605008 for B.Ed. programme for 2 basic units of 50 students each."

- 12. NOW THEREFORE, this order is issued permitting the institution i.e. Immaculate College of Education for Women, Re-survey No. 244/1A, Pakkamudayanpet, Oulgaret Municipality, Pondicherry-605008 for continuation of recognition for B.Ed. Programme of two years duration with an annual intake of (2 basic units) of 50 students each subject to fulfillment of the following conditions:-
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 13. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 14. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

- 15. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students;
  - f. Available infrastructural facilities;
  - g. Facilities added during the last quarter;
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information, if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
  - **16**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
  - 17. The institution shall make available the list of students admitted on its official website.
  - 18. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
