WHEREAS, the recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, College of Physical Education, Kakathiya University, Warangal – 506009, Andhra Pradesh (Now Telangana) vide order no. F.SRO/NCTE/B.P.Ed/2006-2007/2954 dated 17.05.2007 for conducting B.P.Ed. course of one year duration with an annual intake of 50 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted an affidavit on 28.01.2015 for its willingness of one unit in B.P.Ed. course and adherence provisions of new Regulations. A revised provisional recognition order was issued to the institution on 19.05.2015 for conducting B.P.Ed. course of two years duration with an annual intake of one basic unit of 100 (two sections of 50 students each) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 388^{th} meeting held on $14^{th} 15^{th}$ September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 13.04.2021. The institution has not submitted reply to the Show Cause Notice.
- **4. AND WHEREAS,** the SRC in its 408th meeting held on 02nd March, 2022 has considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 11.03.2022. The institution has submitted its reply vide letter dated 11.04.2022.
- **5. AND WHEREAS**, the SRC in its 412th meeting held on 05th 06th July, 2022 has considered the matter and decided to issue a last reminder letter. Accordingly, as per the decision of SRC a last reminder letter was issued to the institution on 26.07.2022. The institution has submitted its reply vide letter dated 05.08.2022.
- **6. AND WHEREAS,** the SRC in its 423rd meeting held on 12th April, 2023 considered the matter and decided as follows: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution College of Physical Education, Kakathiya University, Warangal-506009, Telangana for B.P.Ed. programme for 1 basic unit of 100 students.

- 7. NOW THEREFORE, this order is issued permitting the institution i.e., College of Physical Education, Kakathiya University, Warangal-506009, Telangana for Continuation of recognition for B.P.Ed. programme for two years duration with an annual intake of 1 basic unit of 100 students subject to fulfilment of the following conditions:-
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **8.** Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 9. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 10. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
