WHEREAS, recognition u/s14 Act of NCTE, 1993 was granted to the institution namely, Haji Kareem College of Education, Khasra No. 07, Near Govt, Hospital, Plot No. 7.116, Brahmanakotkur Village, Nandikotkur Taluka, Kurnool District – 518432, Andhra Pradesh vide order No. F.No.APSO9641/B.Ed/AP/2011/30569 dated 29.09.2011 for conducting (B.Ed.) Course of one year duration with an annual intake of 100 students from the academic session 2011-2012.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution had consented to come under new Regulations vide a notarized affidavit dated 07.01.2015. A revised provisional recognition order was issued on 18.03.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the status of issuance of SCN/FSCN was considered by the Sub-Committee constituted by the SRC in its meeting held on 22nd Oct., 2019. The Sub-Committee noted that institutions have not submitted requisite documents or only part reply been submitted. The Sub-Committee decided to issue SCN. Accordingly, as per the decision of SRC a First Show Cause Notice was issued to the institution on 24.10.2019. The institution has submitted reply on 13.11.2019.
- **4. AND WHEREAS,** the SRC in its 384th meeting held on 12th 13th February 2020 has considered the matter and decided to issue a letter. Accordingly, as per the decision of SRC a letter was issued to the institution on 26.02.2020. The institution has not submitted reply to the institution.
- **5. AND WHEREAS**, the SRC in its 412th meeting held on 05th 06th July, 2022 has considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC withdrawal order no. F.SRC/NCTE/APSO9641/B.Ed./AP/2022/132974-132978 dated 25.07.2022 was issued to the institution.
- 6. AND WHEREAS, aggrieved by the withdrawal order dated 25.07.2022 of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. 89-216/E-266819/2022 Appeal/9th meeting, 2022 APPLSRC202214444 dated 30.11.2022 appeal remand back the order appealed against. The institution vide letter dated 08.12.2022 & 03.01.2023 submitted reply to the appeal remand back order.

7. AND WHEREAS, the SRC in its 419th Meeting held on 13th January, 2022 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on perusal of the reply submitted by the institution namely Haji Kareem College of Education decided that the VT with respect to shifting of premises has already been conducted and the VT has submitted its report. In view of the VT report, the institution is permitted to shift their premises to new address i.e. Survey No. 366, 371/B, 366, 345/A2B9 Door No. 7-116, Brahmanakotkur Village, Nandikotkur Mandal, Kurnool District-518432, Andhra Pradesh. The Committee also decided that continuation order be issued to the Institution for B.Ed. programme for 2 basic units of 50 students each."

- 8. NOW THEREFORE, as per the decision of SRC the institution i.e., Haji Kareem College of Education, Khasra No. 07, Near Govt, Hospital, Plot No. 7.116, Brahmanakotkur Village, Nandikotkur Taluka, Kurnool District 518432, Andhra Pradesh is permitted to shift its building at new address at Survey No. 366, 371/B, 366, 345/A2B9 Door No. 7-116, Brahmanakotkur Village, Nandikotkur Mandal, Kurnool District-518432, Andhra Pradesh with an order for continuation of recognition for B.Ed. Programme of two years duration with an intake of (2 basic units) of 50 students each subject to fulfilment of the following conditions:-
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **9.** Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **10.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty

and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

- a. Sanctioned programme(s) along with annual intake in the institution:

- c. Name of faculty members who left of joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- e. Fee charged from students.
- f. Available infrastructural facilities.
- g. Facilities added during the last quarter.
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 13. The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
