WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Sri Raghavendra College of Education, H.No.2-5-104, Satram Street, Allagadda, Kurnool-518543, Andhra Pradesh run by Sri Lakshmi Narasimha Educational Society, Kurnool District-518543, Andhra Pradesh vide order No.F.SRO/NCTE/B.Ed./2007-2008/11098 dated 06.09.2007 for conducting B.Ed. Course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 09.01.2015 and the Revised Provisional Recognition Order(RPRO) was issued to the institution on 06.05.2015 for conducting **B.Ed. Programme** of two years duration with an annual intake of 100 students of two basic units from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 318th meeting held during 08th& 09th August, 2016 considered the matter and decided to issue show cause notice. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 17.09.2016. The institution vide letter dated 22.10.2019 submitted its reply to the show cause notice.
- 4. AND WHEREAS, the SRC in its 381st meeting held on 31st Oct, & 01 Nov, 2019 has considered the matter and decided to issue Continuation order. Accordingly, as per decision of SRC continuation order no. F.No./SRC/NCTE/APSO7445/B.Ed/AP/2019-113220-3227 dated 17.12.2019 was issued to the institution. The institution has submitted written presentation on 15.10.2022 application for shifting of premises D.D. No. 278342 of Rs 1,50,000/- along with requisite documents.
- **5. AND WHEREAS**, the SRC in its 415th meeting held on 03rd 04th November 2022 has considered the matter and decided to constitute the online Visiting Team for shifting of premises for inspection. An online VT for shifting of premises was conducted with three members inspection committee vide dated 15.05.2023 and received on 22.05.2023.
- 6. AND WHEREAS, the SRC in its 426th meeting held on 23rd June 2023 considered the matter and decided to issue a Show Cause Notice. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 03.07.2023. The institution has submitted a reply to the Show Cause Notice on 24.08.2023.

7. **AND WHEREAS**, the SRC in its 428th meeting held on 25th August 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on perusal of the reply submitted by the institution namely Sri Raghavendra B.Ed. College decided that shifting of premises be permitted to the institution at new address i.e. Survey No. 1336, Maruthi Estate-2, N.H.-18, Nannur Village, Orvakal Mandal, Kurnool District-518002, Andhra Pradesh. The Committee also decided that continuation order be issued to the Institution for B.Ed. programme for 2 basic units of 50 students each".

- 8. NOW THEREFORE, this order is issued permitting the institution i.e. Sri Raghavendra B.Ed. College to shift its building at new address at Survey No. 1336, Maruthi Estate-2, N.H.-18, Nannur Village, Orvakal Mandal, Kurnool District-518002, Andhra Pradesh run by Sri Lakshmi Narasimha Educational Society, Kurnool District-518543, Andhra Pradesh for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 2 basic units of 50 students each subject to fulfilment of the following conditions: -
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **9.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **10.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

- 11. - j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **12**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- **13.** The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.
