WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Hindu College of Education, Opp. Sri Venkateshwara Vignana Mandiram Main Road, Guntur District-522003, Andhra Pradesh run by Hindu College & High schools Council, Guntur District, Andhra Pradesh vide order No.F.SRO/NCTE/B.Ed./2008/6132 dated 20.10.2008 for conducting B.Ed. Course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 17.01.2015 and the Revised Provisional Recognition Order(RPRO) was issued to the institution on 26.05.2015 for conducting **B.Ed. Programme** of two years duration with an annual intake of 100 students of two basic units from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 335th meeting held on 11th & 12th April 2017 has considered the matter and decided that the intake capacity of B.Ed. is reduced from 2 units to 1 1 unit and withdraw recognition of 2nd Unit for B.Ed. course from the academic session 2016-2017. Accordingly, as per the decision of SRC, an Order No.F.SRO/APS08756/B.Ed./AP/2016-17/93004 was issued to the institution on 26.04.2017.
- **4. AND WHEREAS,** the SRC in its 388th meeting held on 14th-15th September 2020 considered the matter and decided to issue Show Cause Notices to all the institutions wherein Recognition was accorded by the SRC under Regulations 2014 with the direction to submit all requisite documents. Accordingly, as per decision of SRC, a Show Cause Notice was issued to the institution on 15.07.2023. The institution vide letter dated 18.08.2023 has submitted reply to the Show Cause Notice.
- 5. AND WHEREAS, the SRC in its 428th meeting held on 25th August 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Hindu College of Education, Survey No. 24-2-1/A, 24-1-45, Guntur District-522003, Andhra Pradesh for B.Ed. programme for 1 basic unit of 50 students".

6. NOW THEREFORE, this order is issued permitting the institution i.e. Hindu College of Education, Survey No. 24-2-1/A, 24-1-45, Guntur District-522003, Andhra Pradesh run by Hindu College & High schools Council, Guntur District, Andhra Pradesh for continuation of

recognition for **B.Ed.** Programme for two-years duration with an annual intake of **1 basic unit of 50 students** subject to fulfilment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 7. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 8. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
