## **ORDER**

WHEREAS, Sri Surya Social Service Society's, Prakasam District, Andhra Pradesh had applied for grant of recognition (APS07159) for Sri Buchepallivenkayamma Subbareddy College of Education, Gandhi Nagar, 7<sup>th</sup> Ward, Podili-Ongole Road, Chimakurthi, Prakasam District, Andhra Pradesh in B.Ed course of one year duration under section 14(a) of the NCTE Act, 1993 to the SRC, NCTE, Bangalore.

- 2. AND WHEREAS the Southern Regional Committee, after considering the report of the visiting team as well as other relevant materials granted recognition to the institution for offering **B.Ed** course with an intake of **100** students from the session **2007-2008** vide **Order No.4146** dated **14.06.2007**
- 3. AND WHEREAS the Government of Andhra Pradesh vide letter dated **06.03.2007** forwarded a list of institutions not recommending the names of colleges with the specific reasons with a request to NCTE, SRC to take necessary action against the institutions, this institution is one of the institutions not recommended for D.Ed course. The matter was considered by SRC in its 150<sup>th</sup> meeting held on 28<sup>th</sup>-29<sup>th</sup> December 2007 and SRC after careful consideration of all aspects decided to conduct the inspection of the institution under section 17.
- 4. AND WHEREAS the inspection of the institution was conducted under Section 17 on **24.04.2008** and the report was placed before SRC in its 161<sup>st</sup> meeting held on 6<sup>th</sup>-7<sup>th</sup> August, 2008 and committee decided to serve show cause notice. Accordingly a show cause notice was issued on 26.08.2008.
- 5. AND WHEREAS the institution did not submit written representation even after stipulated period of 30 days. The same was placed before SRC in institution 166<sup>th</sup> meeting held on 18<sup>th</sup>-19<sup>th</sup> October 2008, the SRC after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and came to the conclusion that recognition/permission to the said institution be withdrawn for the following reasons:
  - (I) The institution was required to submit modified, absolute, unconditional, irrevocable lease deed for a period of 30 years for proposed B.Ed course, which was not submitted.
  - (II) The management has submitted lease leed executed on 04.05.2006. But the V.T. was informed about construction of own building.

- (III) The registered lease document of the building taken on lease has not submitted.
- (IV) The certificate with regard to location of land and rented building from Revenue Authorities has not been submitted.
- (V) The institution has not submitted approved new building plan and land documents and no formal permission has been obtained from NCTE for shifting the premises.
- (VI) In the VCD, it is not clear as to which building was shown for inspection.
- (VII) The institution violated the provisions contained under various sections of NCTE Act and regulations there under.

And accordingly a withdrawal of recognition order was issued on 22.10.2008.

6. AND WHEREAS the Correspondent, **Sri Buchepallivenkayamma Subbareddy College of Education, Gandhi Nagar, 7<sup>th</sup> Ward, Podili-Ongole Road, Chimakurthi, Prakasam District, Andhra Pradesh** (hereinafter referred to as the appellant), preferred an appeal dated 19.11.2008 to the National Council for Teacher Education, New Delhi (hereinafter referred to as the Council) under Section 18 of the NCTE Act, 1993 against the said Order.



- 7. AND WHEREAS having considered the verbal submission by the representative of the institution the written representation, the original record of the case and V.T. Report, the Council decided to reverse the order of SRC. Accordingly, the appeal was accepted with direction to SRC to grant recognition to the institution immediately.
- 8. NOW THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the SRC hereby grants recognition/permission to Sri Buchepallivenkayamma Subbareddy College of Education, Gandhi Nagar, 7<sup>th</sup> Ward, Podili-Ongole Road, Chimakurthi, Prakasam District, Andhra Pradesh for conducting B.Ed course of one year duration with an annual intake of 100 students under clause 7(12) of NCTE (Recognition Norms and Procedure) regulation, 2007 subject to fulfillment of the following:-
- I. The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept\_in\_joint-account with SRC, NCTE should be maintained always. Loan raising or mortgaging of FDRs shall not be done.



- II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.
- IV. The institution shall ensure that the required number of academic staff for conducting the course is always in position.

- 9. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc., wherever applicable.
- 10. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S in respect of the salary paid to the staff.
- 11. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1), of the NCTE Act.
- 12. The institution shall maintain & update the web-site as per provisions of NCTE Regulations including inter-alia:
- I. Copy of the Application Form
- II. Land and Building Particulars
- III. Staff Profile
- IV. Recognition Letter
- V. Information in terms of having fulfilled the conditions mentioned above, as and when due.
