WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Shaida College of Education, Plot No. 259/1C, 5C, 5E, Street No. 1 Darsi Village & Post Office, Darsi Taluk & City, Prakasam District, Andhra Pradesh-523247 run by Shaida Moula Educational and Development Society, Plot No. 259/1C, Prajavydyasala Bazar Road, Darsi Village & Post Office, Darsi Taluk & City, Prakasam District, Andhra Pradesh-523247 vide order no. F.SRO/NCTE/SRCAPP2805/B.Ed./AP/2016/83454 on 05.04.2016 for conducting B.Ed. programme of two years duration with an annual intake of 100 students from the academic sessions 2016-2017.

- AND WHEREAS, the SRC in its 408th Meeting held on 02nd March, 2022 considered the matter and decided to issue SCN to all the institutions of Teacher Education Established even after NCTE Regulations, 2014 at the earliest in order to ascertain the compliance of NCTE Regulation, 2014. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution dt. 28.10.2022. The institution has submitted reply to Show Cause Notice on 31.10.2022.
- **AND WHEREAS**, the SRC in its 415<sup>th</sup> Meeting held on 03<sup>rd</sup> & 04<sup>th</sup> November, 2022 3. considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Shaida College of Education, Survey No. 259/1C, 5C & 5E, Kurichedu Road, Darsi Mandal, Darsi Post, Prakasam District-523247, Andhra Pradesh for B.Ed. programme, 2 basic units of 50 students each."

- NOW THEREFORE, this order is issued permitting the institution i.e., Shaida College of Education, Survey No. 259/1C, 5C & 5E, Kurichedu Road, Darsi Mandal, Darsi Post, Prakasam District-523247, Andhra Pradesh run by Shaida Moula Educational and Development Society, Plot No. 259/1C, Prajavydyasala Bazar Road, Darsi Village & Post Office, Darsi Taluk & City, Prakasam District, Andhra Pradesh-523247 for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 2 basic units of 50 students each subject to fulfilment of the following conditions: -
  - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
