## TO BE PUBLISHED IN GAZETTE OF INDIA PART III SECTION 4 WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely, K.S.N.R. College of Education, Penumantra, West Godavari District, Andhra Pradesh-534124 run by Sri Lakshmi Memorial Cottage Industrial Training Centre, West Godavari District, Andhra Pradesh vide SRC vide order no. F.SRO/NCTE/B.Ed./2008-09/3977 dt. 21.08.2008 for conducting (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2008-2009.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 09.05.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 26.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students** for **two basic units** from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 369<sup>th</sup> Meeting held on 28<sup>th</sup> January 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Repost accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, as per decision of SRC Show Cause was issued to the institution on 11.03.2019. The institution has submitted reply on 28.06.2019.
- **4. AND WHEREAS**, the SRC in its 378<sup>th</sup> Meeting held on 25-26<sup>th</sup> July 2019 considered the matter and decided to issue **continuation order**. Accordingly, as per decision of SRC vide order no. F.No.SRC/NCTE/APSO8955/B.Ed./AP/2019/107797-7803 dt. 30.07.2019 for continuation of recognition for B.Ed. course of two years duration with an annual intake of 100 students (two basic units) of 50 students each unit.
- **5. AND WHEREAS,** the institution vide letter dated 13.02.2021 submitted written representation request to close the B.Ed. Programme. The SRC in its 402<sup>nd</sup> meeting held on 13<sup>th</sup> & 14<sup>th</sup> September, 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the institution vide dated 17/02/2021 by withdrawing the recognition granted to K.S.N.R. College of Education, Penumantra, West Godavari District-534124, Andhra Pradesh for conducting B.Ed. Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2021-2022.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in this meeting."

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to K.S.N.R. College of Education, Penumantra, West Godavari District-534124, Andhra Pradesh run by Sri Laxmi Memorial Cottage Industrial Training Centre, West Godavari District, Andhra Pradesh-534124 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 basic units) with effect from the academic session i.e., 2021-2022 onwards.
- **8.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
