WHEREAS, the recognition was granted to the institution namely, Rasi College of Education, No. 25/1B, Thottiya Patti, C.S. Puram Post, Rasipuram Taluk, Namakkal District, Tamilnadu run by Venkateswar Educational and Charitable Trust, Namakkal District, Tamilnadu vide SRC vide order no. F.SRO/NCTE/B.Ed./2006-2007/15900 dt. 11.12.2007 for Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 19.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 13.05.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students** for **two basic units** from the academic session 2015-16.
- 3. **AND WHEREAS**, the institution inspection conducted on 03.09.2016 & 04.09.2016 and VT report was received on 06.09.2016. The request made by the institution for reduction of intake from 2 units to 1 unit. The SRC in its 352<sup>nd</sup> meeting held on 4<sup>th</sup> & 05<sup>th</sup> January 2018 considered the matter and decided to reduction of intake from 2 units to 1 unit. Accordingly, as per decision of SRC vide order no. F.No.SRO/NCTE/APS08948/B.Ed./TN/2018/96404 dt. 15.01.2018 issued reduction order of intake from 2 units to 1 unit in the B.Ed. course is permitted.
- 4. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 04.09.2019. The institution has submitted reply on 25.09.2019.
- **5. AND WHEREAS,** the SRC in its 384<sup>th</sup> meeting held on 12<sup>th</sup> 13<sup>th</sup> February, 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 05.03.2020. The institution has submitted its reply on 24.03.2020.
- 6. **AND WHEREAS,** the SRC in its 388<sup>th</sup> meeting held on 14<sup>th</sup> 15<sup>th</sup> September, 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 21.09.2020. The institution has submitted reply on 10.10.2020.
- 7. AND WHEREAS, the SRC in its 402<sup>nd</sup> Meeting held on 13<sup>th</sup> & 14<sup>th</sup> September, 2021 considered the FSCN reply matter and decided as under: -

furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN) on 21.09.2020. The institution failed to submit reply to the Show Cause Notice.

Hence, the Committee decided to withdraw the recognition granted to Rasi College of Education, No.25/1B, Thottiya Patti, C.S. Puram Post, Rasipuram Taluk, Namakkal District, Tamilnadu for conducting B.Ed. programme with effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 8. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Rasi College of Education, No.25/1B, Thottiya Patti, C.S. Puram Post, Rasipuram Taluk, Namakkal District, Tamilnadu run by Venkateswar Educational and Charitable Trust, Namakkal District, Tamilnadu for conducting B.Ed. programme of two years duration with an annual intake of 50 students (1 basic unit) with effect from the academic session i.e., 2021-2022 onwards.
- **9.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
