WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely, **Sri Raju D.Ed. College, Plot/Khasara No. 606/2 & 606/4, Suddalavandlapalli Road, Rayachoty Village & Post Office, Rayachoty Taluk and City, Kadapa District, Andhra Pradesh – 516269** run by **Raju Educational Society, Suddalavandla Palli Road, Rayachoty Village and Post Office, Rayachoty Taluk & City, Kadapa District, Andhra Pradesh-516269** vide SRC vide order no. F. No. SRCAPP15022/D.El.Ed./AP/2016/84742 dt. 02.05.2016 for conducting (D.El.Ed) programme of two years duration with an annual intake of 50 students from the academic sessions 2016-2017.

2. **AND WHEREAS**, the institution vide letter dated 23.09.2021 submitted written representation request to close the D.El.Ed Programme. The SRC in its 402nd meeting held on 13th & 14th September, 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

*The Committee agreed to close down the institution as requested by the institution vide dated 23.02.2021 by withdrawing the recognition granted to **Sri Raju D.Ed. College, Plot/Khasara No. 606/2 & 606/4 Suddalavandlalli Road, Rayachoty Village & post Office, Rayachoty Taluk and City, Kedapa District 516269, Andhra Pradesh** for conducting **D.El.Ed. Programme** under clause 17(1) of NCTE Act, 1993 from the academic session 2021-2022.*

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in this meeting."

3. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Sri Raju D.Ed. College, Plot/Khasara No. 606/2 & 606/4 Suddalavandlalli Road, Rayachoty Village & post Office, Rayachoty Taluk and City, Kedapa District 516269, Andhra Pradesh** run by **Raju Educational Society, Suddalavandla Palli Road, Rayachoty Village and Post Office, Rayachoty Taluk & City, Kadapa District, Andhra Pradesh-516269** for conducting (D.El.Ed) programme of two years duration with an annual intake of 50 students (1 unit) with effect from the academic session i.e., 2021-2022 onwards.

4. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -



"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

5. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
