WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely, **New Model College of Elementary Education, No. 2/83-2A, Rathna Sabha Pathi Nagar, Siddavatam mandal, Kadapa District, Andhra Pradesh** run by **Sri Sai Educational Society, Kadapa District, Andhra Pradesh** for **D.El.Ed, D.El.Ed-AI** programme as per following details:-

- (i) The SRC vide Order No. F.SRO/NCTE/D.El.Ed./2007-08/579 dt. 22.04.2008 for conducting Elementary (D.El.Ed.) course of two-year duration with an annual intake of 50 students.
- (ii) The SRC vide order No. F.SRO/SRCAPP14570/D.El.Ed./AP/2016/84898 dt. 02.05.2016 for conducting D.El.Ed.-AI. course of two-year duration with one unit of 50 students form the academic sessions 2016-2017.

2. **AND WHEREAS**, the permission is hereby accorded by SRC vide order no. F.SRO/APS05398/D.El.Ed/AP/2016/84375 dated 14.04.2016 to the institution namely **New Model College of Elementary Education, No. 2/83-2A, Rathna Sabha Pathi Nagar, Siddavatam mandal, Kadapa District, Andhra Pradesh** to Shift its Premises to the new location/building at **New Model college of Elementary Education, Thollaganganapalli Village, Cuddapa District, Andhra Pradesh**.

3. **AND WHEREAS**, a letter No. RC. No. 359/A/SCERT/2019 dated 29.06.2020 is received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh on 17.07.2020 recommending therein for de-recognition order in respect of 188 Pvt. D.El.Ed Colleges in A.P. since the said managements of Pvt. D.El.Ed Colleges have made admission into the D.El.Ed Course during academic year 2018-19 on their own in violation of Government orders.

4. **AND WHEREAS**, the SRC in its 386th meeting held on 23rd-24th July 2020 considered the matter and decided to issue Show Cause Notice. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 05.08.2020. The institution has submitted reply received on 07.09.2020.

5. **AND WHEREAS**, the SRC in its 402nd Meeting of SRC held on 13th & 14th September 2021 and considered the matter as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

1. The Committee in its 386th meeting after perusal of the letter No. RC.No. 359/A/SCERT/2019 dated 29.06.2020 received from the Commissioner, School

Education (FAC), School Education Department, Govt. of Andhra Pradesh recommending therein for derecognition order in respect of 188 Pvt. D.El.Ed. colleges in A.P. since the said managements of Pvt. D.El.Ed. colleges have made admissions into the D.El.Ed. course during academic year 2018-19 on their own in violation of Government orders. Accordingly, the SRC decided to issue a Show Cause Notice to all such institutions asking therein to explain about the observations made by the School Education Department, Govt. of Andhra Pradesh vide letter No. R.C.No. 359/A/SCERT/2019 dated 29.6.2020.

2. In view of the above decision a Show Cause Notice dated 05.08.2020 was issued to the institution. The institution has submitted its reply on 07.09.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

- (i) **The Committee perused the letter No. RC No. 359/A/SCERT/2019 dated 29.06.2020 received from the Commissioner, School Education (FAC), School Education Department, Govt. of Andhra Pradesh recommending therein for derecognition order in respect of 188 Pvt. D.El.Ed. colleges in A.P. since the said managements of Pvt. D.El.Ed. Colleges have made admission into the D.El.Ed. course during academic year 2018-19 on their own in violation of Government orders**
- (ii) **The institution has not submitted any document related to SCN.**

Hence, the Committee decided to **withdraw the recognition granted to New Model College of Elementary Education, Plot No. 100/1, Thollagana Street, Thollanganapalli Village and Post Office, Chennur Taluk, Kadapa Town, Kadapa District-516162, Andhra Pradesh for conducting D.Ed. alongwith additional intake programmewith effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.**"

6. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **New Model College of Elementary Education, Plot No. 100/1, Thollagana Street, Thollanganapalli Village and Post Office, Chennur Taluk, Kadapa Town, Kadapa District-516162, Andhra Pradesh run by Sri Sai Educational Society, Kadapa District, Andhra Pradesh for conducting D.El.Ed. & D.El.Ed.-AI course of two years duration with an annual intake of 50 students for (D.El.Ed.) & 50 students for (D.El.Ed.-AI) course with effect from the academic session i.e. 2021-2022 onwards.**

7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
