WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely J.V.R.R. Memorial College of Education, Lakshmikanta Reddy Estate, Railway Station Road, Nandyal-518502, Andhra Pradesh vide order No. F. AP/B.Ed./Ext/44/SRO/NCTE/2000-2001/1595 dated 18.08.2000 for conducting B.Ed. Course of one-year duration with an annual intake of 160 students from the academic session 2000-2001.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution submitted affidavit dated 09.01.2015 for its willingness & adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 26.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 150 (three basic units of 50 students each) from the academic session 2015-16.
- 3. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th Meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC, Show Cause Notice was issued to the institution on 06.03.2019. The institution vide letter dated 22.03.2019 submitted reply to the show cause notice.
- **4. AND WHEREAS**, the SRC in its 376th meeting held on 11th& 12th June, 2019 considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC a vide withdrawal order no. F.SRO/NCTE/APSO0282/B.Ed/AP/2019/106721-6726 dated 10.07.2019 was issued to the institution.
- 5. AND WHEREAS, the Legal Counsel vide note page 16/n submitted that the institution file W.P.No. 7428 of 2019 titled as J.V.R.R. Memorial College of Education Vs. NCTE and others before the Hon'ble Court of Delhi and submitted the following:-
 - "...FR is a copy of written representation received at this office vide email dated 22.07.2019 from above captioned institution in the present matter.
 - 2. The matter was listed before the Hon'ble High Court of Delhi on 12.07.2019 against the withdrawal order passed by the SRC. After pursuance of court order the Hon'ble High Court has directed "Notice of the petition is accepted on behalf of respondent. The Counter Affidavit be filed within a period of four weeks. Till the next date of hearing the operation of the impugned to the petitioner is stayed. List the matter on 23.09.2019"
 - 3. Further, it is requested by the institution if desired by the SRC the institution will resubmit the documents. Accordingly, it is requested to comply with the order

and to issue the necessary order affecting the stay of the withdrawal. Also, it is further requested to update the affiliating body and the counselling authority so that institute can participate in the counselling.

- 4. In pursuance of above, it is suggested that the since the matter has been stayed by the Hon'ble High Court it is to be considered in SRC upcoming meeting.
- 6. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-137/E-313009/2023 Appeal/7th Meeting, 2023 Appeal No.APPLSRC202314646 dated 17.08.2023 and the Appeal Committee decided to remand back the case to SRC. The institution has submitted a reply to the Appeal Remand back Case on 24.08.2023.
- 7. AND WHEREAS, the SRC in its 428th meeting held on 25th August 2023 considered the inspection report for shifting premises as decided as under:-

"The original file of the Institution alongwith other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations:-

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution J.V.R.R. Memorial College of Education, Survey No. 674/2 26th Ward, Lakshmikanta Reddy Estate, Railway Station Road, Nandyal, Nandyal District-518502, Andhra Pradesh for B.Ed. programme 3 basic unit of 50 students each."

- 8. NOW THEREFORE, this order is issued permitting the institution i.e. J.V.R.R. Memorial College of Education, Survey No. 674/2 26th Ward, Lakshmikanta Reddy Estate, Railway Station Road, Nandyal, Nandyal District-518502, Andhra Pradesh for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (3 basic units) of 50 students each subject to fulfilment of the following conditions:-
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **9.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

- **10.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **12**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 13. The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
