WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Sri Chandrasekharendra Saraswathi Viswa Maha Vidyalaya School of Education, Enathur, KAANCHEEPURAM, Kancheepuram District-631561, TamilNadu run by Sri Kanchee Kamakoti Peetam Charitable Trust, Kancheepuram District, TamilNadu vide order No.F.SRO/NCTE/B.Ed./2006-2007/10532 dated 03.02.2007 for conducting B.Ed. Course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 20.01.2015 and the Revised Provisional Recognition Order(RPRO) was issued to the institution on 30.04.2015 for conducting **B.Ed. Programme** of two years duration with an annual intake of 100 students of two basic units from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 369th Meeting held on 28.01.2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted requisite documents/VT report accompanied with requisite documents in responds to RPRO issued by the SRC. Accordingly, as per decision of SRC a Show Cause was issued to the institution 02.05. 2019. The institution did not submit a reply to the Show Cause Notice.
- 4. AND WHEREAS, the SRC in its 410th Meeting held on 25th & 26th April 2022 considered the matter and committee decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 12.05.2022. The institution vide letter dated 28.05.2022 has submitted reply to the Final Show Notice.
- 5. AND WHEREAS, through E-office, the institution has been submitted the reply vide E-receipt No. 119628/2019/RDSRC in which is requested only 1 unit instead of two units. As per SCN dated 02.05.2019, documents are requested in compliance of SCN institution has submitted.
- 6. AND WHEREAS, the SRC in its 413th meeting held on 22nd and 23rd August, 2022 considered the matter and committee decided to issue Show Cause Notice(PAR). Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution

- 7. AND WHEREAS, the SRC 417th meeting held on 1st & 2nd December 2022 considered the matter and committee and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 20.02.2023. The institution has submitted a reply vide letter dated 02.03.2023.
- 8. AND WHEREAS, the SRC in its 428th meeting held on 25th August 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Sri Chandrasekharendra Saraswathi Viswa Maha Vidyalaya School of Education, Survey No. 754/2C, 754/1A, 754/1B1, 754/2C, Engathur, Kancheepuram, Kancheepuram District — 631561, Tamilnadu for B.Ed. programme for 1 basic unit of 50 students".

- 9. NOW THEREFORE, this order is issued permitting the institution i.e. Sri Chandrasekharendra Saraswathi Viswa Maha Vidyalaya School of Education, Survey No. 754/2C, 754/1A, 754/1B1, 754/2C, Engathur, Kancheepuram, Kancheepuram District 631561, Tamilnadu run by Sri Kanchee Kamakoti Peetam Charitable Trust, Kancheepuram District, TamilNadu for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions:-
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

- **10.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 11. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 12. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter:
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
