WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Ragavendra College of Education, Karatur Road, Sathyamangalam-638402, Erode District, TamilNadu run by Ragavendra Educational Trust, Erode District, TamilNadu vide order No.F.SRO/NCTE/B.Ed./2006-2007/7415 dated 01.09.2006 for conducting B.Ed. Course of one-year duration with an annual intake of 100 students from the academic session 2006-2007.

- 2. AND WHEREAS, a Corrigendum was issued to the institution vide order no. F.No.APS05576/B.Ed./2012-2013/45977 dt. 10.09.2012 permission hereby accorded by SRC to Sri Ragavendra College of Education, Karatur Road, Sathyamangalam, Erode District. Tamilnadu-638402 to shift its premises to the new location/building at Sri Ragavendra College of Education, Sy no. 94/2, 95/2, 95/3, Near Govt. Hospital, Komarapalayam Panchayat, Sathyamangalam Taluk, Erode District, Tamilnadu-638401.
- AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 21.01.2015 and the Revised Provisional Recognition Order (RPRO) was issued to the institution on 31,03,2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 students of two basic units from the academic session 2015-16.
- AND WHEREAS, the SRC in its 388th meeting held on 14th 15th September 2020 has considered the matters and the Committee decided to issue Show Cause Notice in all such matters where the institution has not submitted the requisite documents/VT report not accompanied with the requisite documents In case no reply or part reply to SCN is received by the SRC Office. The RD is also authorized to issue Final SCN in all such matters. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 04.01.2020. The institution did not submit any reply to Show Cause Notice. Accordingly, as per the decision, a Final Show Cause Notice was issued to the institution on 22.01.2021. The institution submitted its reply on 15.02.2021.
- AND WHEREAS, the SRC in its 408th meeting held on 2nd March 2022 has considered the matters and the Committee decided to withdraw the recognition to the institution. Accordingly, withdrawal order was issued to the institution on 14.03.2022 vide order no. SRO/NCTE/APSO5576/B.Ed./TN/2022/130718-130722.
- AND WHEREAS, the institution has filed Writ Petition before Hon'ble High Court of Delhi bearing W.P (C) No.14400/2022 titled as Sri Ragavendra College of Education versus National Council for Teacher Education & Anr. Whereby the Hon'ble High Court. In compliance of order dated 11.10.2022, the Regional Director, SRC has already passed an order no. File No.SRO/NCTE/APSO5576/B.Ed./TN/2022/136410-136412 vide atted 19.10.2022 was issued.

7. **AND WHEREAS**, the SRC in its 415th meeting held on 03rd – 04th November 2022 has considered the matter and decided as under: -

"In Compliance of order dated 11.10.2022 passed by the Hon'ble High Court of Delhi at New Delhi in W.P (C) No.14400/2022 titled as Sri Ragavendra College of Education versus NCTE & Anr., the Regional Director has issued order dated 19.10.2022, the Committee ratified the said order".

Accordingly, as per the decision of SRC, a letter was issued to the institution on 22.11.2022.

- 8. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-140/E-255686/2022 Appeal/8th Meeting, 2022 Appeal No.APPLSRC202214365 dated 16.11.2022 appeal deserved to be rejected and therefore the impugned order of SRC is confirmed.
- 9. AND WHEREAS, the SRC in its 417th meeting held on 01st & 02nd December 2022 has considered the appeal order and decided that the Appellate Authority confirming the withdrawal order.
- 10. AND WHEREAS, the appellant institution moved a writ petition before the Hon'ble High Court of Delhi at New Delhi Bench bearing W.P. No.17063/2022 & CM APPL 54076/2022 titled Sri Ragavendra College of Education v/s National Council for Teacher Education & Anr, the Hon'ble Court vide its order dated 12.05.2023.
- 11. AND WHEREAS, in compliance of the Hon'ble Court order dated 12.05.2023, Appellate Authority of the NCTE has passed vide order No. 89-140/E-255686/2022 Appeal/7th Meeting, 2023 Appeal No.APPLSRC202214365 dated 13.07.2023 remanding back the case of the institution to the SRC.The institution has submitted a reply through E-Mail vide dated 18.08.2023 as per direction of Appellate Authority...
- 12. AND WHEREAS, the SRC in its 428th meeting held on 25th August 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Sree Sri Ragavendra College of Education, Sy No. 94/2, 95/2, 95/3, Near Govt. Hospital, Komarapalayam Panchayat, Sathyamangalam Taluk, Erode District, Tamilnadu-638401 for B.Ed. programme for 2 basic units of 50 students each".

12. NOW THEREFORE, this order is issued permitting the institution i.e. Sri Ragavendra College of Education, Sy no. 94/2, 95/2, 95/3, Near Govt. Hospital, Komarapalayam Panchayat, Sathyamangalam Taluk, Erode District, Tamilnadu-638401run by Ragavendra Educational Trust, Erode District, Tamilnadu for continuation of recognition for B.Ed.

Programme for two-years duration with an annual intake of 2 basic units of 50 students each subject to fulfilment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 13. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **14.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 15. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities:
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
