WHEREAS, permission u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely SA-YA Gosh College of Education, Sa-Ya Gosh Nagar, K.N. halli, Bysuhalli Post, Dharmapuri-635205, TamilNadu run by SA-YA Gosh Educational Trust, Dharmapuri District, TamilNadu vide order No. F.SRO/NCTE/M.Ed./2008/6164 dated 21.10.2008 for conducting M.Ed. Course of one-year duration with an annual intake of 25 students. The enhancement of intake of 10 seats from existing 25 to 35 is permitted vide order No.F.SRO/NCTE/2010-2011/20665 was issued to the institution on 25.08.2010 for M.Ed. Couse from the academic session 2010-2011.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 23.01.2015 and the Revised Provisional Recognition Order(RPRO) was issued to the institution on 22.05.2015 for conducting M.Ed. Programme of two years duration with an annual intake of 50 students (one unit) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 considered the matter and decided to issue Show Cause Notice to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 15.03.2019. The institution did not submit reply to the Show Cause Notice.
- 4. AND WHEREAS, the matter was further considered by the Sub-Committee constituted by the SRC as per its decision taken in 380<sup>th</sup> meeting. The Sub-Committee decided to issue Final Show Cause Notice to all such institutions where replies to SCN have not been submitted by the institution. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 18.03.2020.
- 5. AND WHEREAS, the SRC in its 395<sup>th</sup> meeting held on 25<sup>th</sup>-26<sup>th</sup> February 2021 considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a Withdrawal Order No. F.SRO/NCTE/APSO8017/M.Ed./{TN}/2021/125269-5276 was issued to the institution on 23.03.2021.
- 6. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appeal Committee of the Council concluded that the SRC was justified in withdrawing recognition and therefore the instant appeal deserved to be rejected and the impugned withdrawal order was confirmed vide appeal order no. 89-150/E-256912/2022 Appeal/5<sup>th</sup> Meeting, 2022 APPLSRC202114242 dated 12.07.2022.

- 7. AND WHEREAS, the institution filed a writ petition before the Hon'ble High Court of Judicature at Madras bearing W.P. No. 21289/2023 & W.M.P. Nos. 20691 & 20694 of 2023 titled as Sa-Ya Gosh College of Education V/s National council for Teacher Education & Anr. The Hon'ble court vide its order dated 19.07.2023 issued the directions upon the Appellate Authority.
- **8. AND WHEREAS,** the Appeal Committee of the Council considered the matter and concluded to remand back the case to SRC with a direction to re-verify the documents submitted in appeal and take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time vide appeal order no. 89-150/E-256912/2022 Appeal/8<sup>th</sup> Meeting, 2023 APPLSRC202114242 dated 17.08.2023. The institution vides letter dated 18.08.2023 and 22.08.2023 has submitted reply to the Appeal Remand Back Order.
- 9. AND WHEREAS, the SRC in its 428<sup>th</sup> meeting held on 25<sup>th</sup> August 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution SA-YA Gosh College of Education, Boomanadhahalli 218, 2019, 220/2 & 221/1, Boomanadhahalli Panchayat, Karimanagalam Union, Dharmapuri-635205, Tamil Nadu for M.Ed. programme 1 basic unit of 50 students".

- 10. NOW THEREFORE, this order is issued permitting the institution i.e. SA-YA Gosh College of Education, Boomanadhahalli 218, 2019, 220/2 & 221/1, Boomanadhahalli Panchayat, Karimanagalam Union, Dharmapuri-635205, Tamil Nadu run by SA-YA Gosh Educational Trust, Dharmapuri District, TamilNadu for continuation of recognition for M.Ed. Programme for two-years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions:-
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

- **11.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **12**. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake, available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students:
  - f. Available infrastructural facilities:
  - g. Facilities added during the last quarter;
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **14**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 15. The institution shall make available the list of students admitted on its official website.
- 16. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
