WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, Periyar University, Plot No. 24/1, Karuppur Village, Salem PU Post Office, Omalur Taluk, Salem City and District, Tamilnadu-636011 run by Periyar University Dept of Education, Plot No. 24/1, Bangalore Main Road NH-7, Kottagoundampatty Village, Salem PU Post Office, Omalur Taluk, Salem City and District, Tamilnadu-636011 vide order no. SRO/NCTE/SRCAPP3427/B.Ed. Part -Time/TN/2016-2017/85034 dt. 02.05.2016 for conducting B.Ed. Part-time programme of three years duration with an annual intake of 100 students (2 units) from the academic sessions 2016-2017.

- AND WHEREAS, the Registrar of Periyar University has submitted written 2. representation dt. 14.07.2023 for discontinue of the B.Ed. (Part -time) course.
- AND WHEREAS, the SRC in its 428th Meeting held on 25th August, 2023 has considered the matter/written representation and decided as under: -

"The original file of the Institution alongwith other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

The Committee accepted the request made by the institution i.e., Perivar University Department of Education, Periyar University, Department of Education, Periyar University, Salem, Tamilnadu-636011 for discontinuation the B.Ed. (Part-time) programme. Orders may be issued accordingly."

- 4. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution as requested by withdrawing recognition granted to Periyar University, Plot No. 24/1, Karuppur Village, Salem PU Post Office, Omalur Taluk, Salem City and District, Tamilnadu-636011 run by Periyar University Dept of Education, Plot No. 24/1, Bangalore Main Road NH-7, Kottagoundampatty Village, Salem PU Post Office, Omalur Taluk, Salem City and District, Tamilnadu-636011 for conducting B.Ed. Part – Time programme of three years duration with an annual intake of 100 students (2 units) with effect from the end of the academic session next following the date of withdrawal order.
- 5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day

fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

"यिद कोई संस्था उप-धारा (1) के तहत मान्यता वापस लेने के आदेश के लागू होने के बाद शिक्षक शिक्षा में कोई पाठ्यक्रम या प्रशिक्षण प्रदान करती है या जहां कोई संस्थान नियत दिन से ठीक पहले शिक्षक शिक्षा में पाठ्यक्रम या प्रशिक्षण प्रदान करने में विफल रहता है या इस अधिनियम के तहत मान्यता या अनुमित प्राप्त करने हेतु उपेक्षा करता है, तो ऐसे पाठ्यक्रम या प्रशिक्षण के अनुसार या ऐसी संस्था में पाठ्यक्रम या प्रशिक्षण लेने के बाद प्राप्त शिक्षक शिक्षा में योग्यता को केंद्र सरकार, किसी राज्य सरकार या विश्वविद्यालय या केन्द्रीय सरकार या किसी राज्य सरकार द्वारा सहायता प्राप्त किसी स्कूल, कॉलेज या अन्य शैक्षिक संस्था में रोजगार के उद्देश्य के लिए वैध योग्यता के रूप में नहीं माना जाएगा।")

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
