WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Navya Chaitanya College of Education, Kandukur Revenue Division O.V. Road, Kandukur, Prakasam, Pin-523105, Andhra Pradesh vide order No. F. AP/NEW/B.ED./152 /SRO/NCTE/2002-2003/6140 dated 28.02.2003 for conducting B.Ed. Course of one-year duration with an annual intake of 100 students from the academic session 2002-2003.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution submitted affidavit dated 17.01.2015 for its willingness & adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 11.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units of 50 students each) from the academic session 2015-16.
- AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on 30.04.2019. The institution has not reply to Show Cause Notice.
- AND WHEREAS, the SRC in its 381st meeting held on 31st Oct & 01st Nov 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Further the Committee also suggested on receiving the reply to the SCN, the SRO may scrutinize the documents and still if there are some deficiency/lapses, the RD is authorized to issue Final SCN and then place the cases before the SRC for its perusal and decision. Accordingly, a Final Show Cause Notice was issued to the institution on 06.11.2019. The institution vide dated 12.12.2019 submitted reply in response to the Final Show Cause Notice.
- AND WHEREAS, the SRC in its 390th meeting held on 28th& 29th October 2020 considered the matted and committee decided the institution vide letter dt. 12.12.2019, the Committee decided that the continuation order be issued to the Institution. Accordingly, as per the decision of SRC a continuation order No. SRC/NCTE/APS00365/B.Ed./AP/2020/120232-0239 was issued to the institution on 02.11.2020.
- AND WHEREAS, the institution has submitted shifting application vide letter dated 27.05.2023 alongwith requisite documents.
- AND WHEREAS, the SRC in its 426th meeting held on 23rd June 2023 considered the matter and committee decided to constitute the online Visiting Team for inspection of infrastructural & instructional facilities etc. Accordingly, as per the decision of SRC VT was
