CONTINUATION ORDER

WHEREAS, the recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely **Rajiv Gandhi College of Education, Kattinayanapalli Village & Post, Krishnagiri-635001, TamilNadu** run by **Sri Balaji Educational Trust, Krishnagiri District, TamilNadu** vide order No. F.SRO/NCTE/B.Ed./2006-2007/16027 dated 17.12.2007 for conducting **Secondary B.Ed. Course** of one-year duration with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution submitted affidavit dated 19.01.2015 for its willingness & adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 30.04.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

3. **AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on 28.03.2019. the institution did not submitted reply of SCN.

4. **AND WHEREAS**, the SRC in its meeting held on 18th – 19th September, Meeting 380th The Sub-Committee noted that institutions have not submitted requisite documents or only part reply has been submitted. The Sub-Committee decided to issue SCN. Accordingly, a Final Show Cause Notice was issued to the institution on 15.11.2019. The institution has submitted reply of Final Show Cause Notice on 13.10.2021.

5. **AND WHEREAS**, the SRC in its 404th meeting held on 16th – 17th November 2021 was considered the matter and decided to withdraw the Recognition Accordingly, as per the decision of SRC, a Withdrawal Order No.F.SRO/NCTE/APS08004/B.Ed./{TN}/2021/129348 dated 01.12.2021 was issued to the institution.

6. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-118/E-251605/2022 Appeal/5th Meeting, 2022 Appeal No.APPLSRC202214345 dated 12.07.2022 appeal remand back the order appealed against. The institution vide letter dated 25.07.2022 has submitted a reply to the Appeal Remand Back Case.

7. **AND WHEREAS**, the institution has filed W.P. No.29800 of 2022 on the Hon'ble High Court of Judicature at Madras and passed order dated 24.01.2023 reproduced as below:-

"Till those proceedings are completed in entirety, it has to be deemed that the recognition of the petitioner subsists. Therefore, the impugned order of the 2nd respondent dated 29.03.2022, specifically withdrawing recognition is interfered with and is set aside. The 1st respondent may wait for final and clear orders from either the original Authority or from the Appellate Authority and thereafter take a decision about the withdrawal or otherwise of the recognition".

8. **AND WHEREAS**, the SRC in its 421st meeting held on 10th February 2023 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 20.02.2023. The institution vide dated 03.03.2023 has submitted a reply to the Final show Cause Notice.

9. **AND WHEREAS**, the SRC in its 427th meeting held on 20th July 2023 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

*The Committee on the perusal of the reply submitted by the institution, decided that the **continuation order** be issued to the Institution **Rajiv Gandhi College of Education, Survey No. 413/2, 413/4, 414/2, 414/5, Kattinayanapalli Village, Kuppam Road, Kammampalli Post, Krishnagiri District-635120, TamilNadu for B.Ed. programme for 2 basic units of 50 students each.**"*

10. **NOW THEREFORE**, this order is issued permitting the institution i.e. **Rajiv Gandhi College of Education, Survey No. 413/2, 413/4, 414/2, 414/5, Kattinayanapalli Village, Kuppam Road, Kammampalli Post, Krishnagiri District-635120, TamilNadu** for continuation of recognition for **B.Ed. Programme** for two-years duration with an annual intake of **(2 basic units) of 50 students each** subject to fulfilment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.



11. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

12. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

15. The institution shall make available the list of students admitted on its official website.

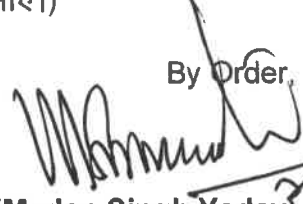
16. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

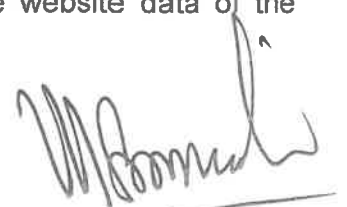
