WITHDRAWAL ORDER

WHEREAS, the recognition u/s 14 of NCTE Act, 1993 was granted to the institution namely Sri Venkatachalapathy College of Education, Plot No. 418, Venugopalpuram Village, Kilnachipattu Post, Tiruvannamalai Taluk & District-606611, Tamilnadu run by Sri Venkatachalapathy, Educational Trust, Plot No. 418, New Pass Road, Venugopalai Taluk & District-606611, TamilNadu vide SRC (NCTE) Order No. F.No.SRO/NCTE/SRCAPP30 /B.Ed-AI/TN/2015/62237 dated 03.03.2015 for conducting B.Ed-AI programme of two-years duration with an annual intake of 100 students two units from the academic session 2015-2016.

2. **AND WHEREAS**, a letter dated 15.09.2022 has received from management of the institution for closure of B.Ed-AI Programme.

3. **AND WHEREAS**, the SRC in its 414th Meeting held on 26th – 27th September 2022 considered the matter for closure and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made were made: -

The Committee agreed to close down the institution as requested by the Institution vide letter dated 15.09.2022 by withdrawing the recognition granted to Sri Venkatachalapathy College of Education, Plot No. 418, Venugopalpuram Village, Kilnachipattu Post, Tiruvannamalai Taluk & District-606611, Tamilnadu for conducting B.Ed-AI Programme is withdrawn under Section 17(1) of NCTE Act, 1993 from the academic year 2023-2024.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in its earlier meeting."

4. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Sri Venkatachalapathy College of Education, Plot No. 418, Venugopalpuram Village, Kilnachipattu Post, Tiruvannamalai Taluk & District-606611, Tamilnadu run by Sri Venkatachalapathy, Educational Trust, Plot No. 418, New Pass Road, Venugopalai Taluk & District-606611, TamilNadu for conducting B.Ed-AI programme of two years duration with an annual intake of 100 students two units 50 each with effect from the academic session i.e., 2023-2024 onwards.

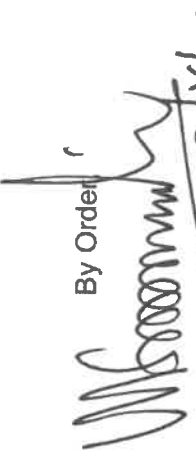

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

“If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government.”

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through “online mode” available on NCTE’s website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE’s website.

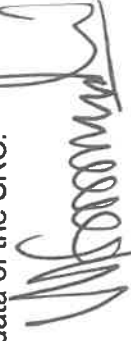
