NOW THEREFORE, in exercise of the powers vested under Section14(3) (a) of the NCTE Act, 1993, the Regional Committee, NCTE hereby grants recognition to Pedada Bharathi Devi College of Education, Plot No. 368/1, Street No. 1-1, Ijjavaram Village, Naupada RS Post, Santhabommali Taluk and City, Srikakulam District-532212, Andhra Pradesh for conducting B.Ed programme of two years duration with an annual intake of 100 students (2 units) from the academic sessions 2016-2017 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

- The Endowment fund of Rs.5 lakhs and Reserve fund of Rs.7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDR's shall not be done.

- The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
