WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Sri Venkateshwara College of Education, Thagguvari Palli, Gujula Palli Road, Bangarupalyam, Chittoor District-517416, Andhra Pradesh run by Sri Venkateshwara Educational and Charitable Trust, Chittoor District-517416, Andhra Pradesh vide order No.F.SRO/NCTE/B.Ed./2008-09/3716 dated 11.08.2008 for conducting B.Ed. Course of oneyear duration with an annual intake of 100 students from the academic session 2008-09.

- AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 11.06.2015 and the Revised Provisional Recognition Order(RPRO) was issued to the institution on 03.07.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 students for two basic units from the academic session 2015-16.
- AND WHEREAS, the SRC in its 388th meeting held on 14th \$4.15th September 2020 was placed before the Committee and decided to issue Show Cause Notice to the institution. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 13.04.2021.
- AND WHEREAS, the SRC in its 400th meeting held on 13th 14th July 2021 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 03.08. 2021. The institution did not submit any reply to the Final Show Cause Notice.
- AND WHEREAS, the SRC in its 411th meeting held on 23rd -24th April, 2022 the matter 5. was considered and decided to withdraw the recognition to the institution. Accordingly, as per decision of SRC, a withdrawal order No. F.SRO/NCTE/APS08946/B.Ed./AP/2022/132373-132377 was issued to the institution on 04 06 2022
- AND WHEREAS, the institution has filed Writ Petition before Hon'ble High Court of Delhi for bearing W.P (C) No. 15438/2022 & CM APPLs. 47969/2022 titled as Sri Venkateswara College of Education Versus National Council for Teacher Education. In compliance of order dated 10.11.2022, the Regional Director, SRC has already passed an order dated 25.11.2022 vide order no. File No.SRO/NCTE/APSO8946/B.Ed./AP/2022/137597-137599. This is only for confirmation.
- AND WHEREAS, the SRC in its 417th meeting held on 01st 02nd December has 7. considered the matter and decided to the institution is permitted to participate in process of counselling for the academic session 2022-2023. Accordingly, as per the decision of SRC, a letter was issued to the University on 13.12.2022.

- **8. AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-202/E-263042/2022 Appeal/11<sup>th</sup>Meeting ,2023Appeal No. APPLSRC202214429 dated 10.10.2023 appeal remand back the order appealed against. The institution has submitted a reply to the Appeal Remand Back through an E-Mail dated 11.10.2023.
- 9. AND WHEREAS, the SRC in its 429<sup>th</sup> meeting held on 11<sup>th</sup> September 2023 has considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Sri Venkateshwara College of Education, Survey No. 357/358, 5<sup>th</sup> KM, Gajulapalli Road, Sadakuppam Village and Post, Bangarupalyam Taluk, Chittoor District, Andhra Pradesh-517416 for B.Ed. programme 2 basic units of 50 students each".

- 10. NOW THEREFORE, this order is issued permitting the institution i.e. Sri Venkateshwara College of Education, Survey No. 357/358, 5<sup>th</sup> KM, Gajulapalli Road, Sadakuppam Village and Post, Bangarupalyam Taluk, Chittoor District, Andhra Pradesh-517416 run by Sri Venkateshwara Educational and Charitable Trust, Chittoor District-517416, Andhra Pradesh for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of 2 basic units of 50 students each subject to fulfilment of the following conditions:-
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 11. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

- **12.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students;
  - f. Available infrastructural facilities;
  - g. Facilities added during the last quarter;
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **14**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 15. The institution shall make available the list of students admitted on its official website
- 16. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
