WHEREAS, recognition u/s 14 Act of NCTE, 1993 was granted to the institution namely Sarada College of education, D.No.3/164, Prathapnagar, Madras Road, Cinnachowk, Sankarapuram, Kadapa-516002, Andhra Pradesh, run by Sri Sarada Memorial Educational Society, Kadapa District, Andhra Pradesh vide order no. No.F.SRO/NCTE/B.Ed./2007-2008/17269 on 22.01.2008 for conducting (B.Ed.) course of one year duration from the academic session 2007-2008 with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 19.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 342<sup>nd</sup> meeting held on 05<sup>th</sup>-06<sup>th</sup> July 2017 considered the matter and decided to reduction of intake strength from 2 units to 1 unit. Accordingly, as per decision of SRC an order No. F.No.SRO/NCTE/APS09072/B.Ed./AP/2017-18/94099 was issued to the institution on 21.07.2017 for reduction of intake from 2 units to 1 unit.
- 4. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, a Show Cause Notice was issued on 18.02.2019. The institution did not submitted reply in response to the Show Cause Notice.
- 5. AND WHEREAS, the SRC in its 381<sup>st</sup> meeting held on 31<sup>st</sup> Oct & 01<sup>st</sup>Nov, 2019 has considered the matter and the decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, a Final Show Cause Notice was issued to the institution on 10.12.2019. The institution did not submit any reply in response to the Final Show Cause Notice.
- **6. AND WHEREAS,** the SRC in its 411<sup>th</sup> meeting held on 23<sup>rd</sup> & 24<sup>th</sup> May, 2022 had considered the matter and decided to withdraw the recognition. Accordingly, as per the decision of SRC, a Withdrawal Order No. F.SRC/NCTE/APS09072/B.Ed./AP/2022/132368-132372 was issued to the institution on 04.06.2022.
- 7. **AND WHEREAS,** the institution had filed WP. No. 27687 of 2023 in the Hon'ble High Court of Andhra Pradesh at Amaravati title Sarada College of Education versus The State of Andhra Pradesh & others. Whereby the Hon'ble High Court vide its order dt. 19.10.2023 had directed that: -

"5. Having regard to submissions made by learned counsel for the petitioner as well as learned Standing Counsel, this Court is of the considered view that the present Writ Petition can be disposed of, directing the 3rd respondent herein to consider the representation of the petitioner dated 03.10.2023 by providing an opportunity of hearing to the petitioner within a period of three (03) weeks from the date of receipt of copy of this order. There shall be no order as to costs.

Consequently, Miscellaneous Petitions, if any, pending in the writ petition shall stand closed."

- 8. AND WHEREAS, as per direction of the Hon'ble High Court of Andhra Pradesh order dated 19.10.2023, the representation of the institution dated 03.10.2023 was considered by the SRC.
  - 9. AND WHEREAS, the SRC in its 430<sup>th</sup> Meeting held on 01<sup>st</sup> December, 2023 considered the matter and decided as follows: -

"The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

In the compliance of Court order dated 19.10.2023 passed by the Hon'ble High Court of Andhru Pradesh at Amravati in WP No. 27687 of 2023, the representation dated 03.10.2023 was considered and Committee decided to issue continuation order of the institution i.e., Sarada College of Education, Survey No. 2/1, Putlam Palli (V), Chinna Chowk, Kadapa District-516002, Andhra Pradesh for B.Ed. programme for 1 basic unit of 50 students."

- 10. NOW THEREFORE, this order is issued permitting the institution i.e. Sarada College of Education, Survey No. 2/1, Putlam Palli (V), Chinna Chowk, Kadapa District-516002, Andhra Pradesh for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions:
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 11. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

- 12. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
  - e. Fee charged from students.
  - f. Available infrastructural facilities.
  - g. Facilities added during the last quarter.
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 15. The institution shall make available the list of students admitted on its official website.
- 16. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
