WHEREAS, the recognition was granted to the institution namely Rabindranath Tagore College of Education for Women, Veerachipalayam Vilalge, Somkeri West, Sankari Tamilnadu-637303 SRC (NCTE) vide District, F.SRO/NCTE/M.Ed./2006-2007/6751 dt. 17.07.2007 for conducting M.Ed. course of one year duration with an annual intake of 25 students.

- AND WHEREAS, the consequent upon the notification of the National Council for Teacher Education (Amendment) Regulation, 2010 on dt. 26.07.2010 the intake of existing 25 students in M.Ed. course was increased from 25 to 35 vide SRC, NCTE order dt. 26.08.2010.
- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 22.01.2015 for its willingness for adherence of provisions of new Regulations. The Revised Provisional Recognition Order was issued to the institution on dt. 22.05.2015 for conducting M.Ed. programme of two years duration with an annual intake of 50 (one unit) from the academic session 2015-16.
- AND WHEREAS, the matter regarding compliance by the institution of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institution have not submitted compliance. Accordingly, as per decision a Show Cause Notice was issued to the institution on 14.08.2019. Thereafter, the institution has submitted its reply on dt. 07.09.2019.
- AND WHEREAS, the matter was placed before the SRC in its 400th meeting held on 13th - 14th July 2021 and the Committee decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Rabindranath Tagore College of Education for Women, Survey No. 27/1A3, 1A4, 1B3, 1B4, 1C3, 2B2, 2B4, 27/2C1, 2D1, 3A,3C,3B,4 Veerachipalayam Village, Sankagiri Taluk, Salem District-637303, Tamilnadu for M.Ed. programme for 1 basic unit of 50 students."

NOW THEREFORE, the SRC decided to permit the institution i.e., Rabindranath Tagore College of Education for Women, Survey No. 27/1A3, 1A4, 1B3, 1B4, 1C3, 2B2, 2B4, 27/2C1, 2D1, 3A,3C,3B,4 Veerachipalayam Village, Sankagiri Taluk, Salem District-637303, Tamilnadu for continuation of recognition for M.Ed. programme for two year duration 1 basic unit (50 students) subject to fulfilment of the following conditions:

 The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

I. The institution shall comply with the various other norms and standards prescribed

in the NCTE Regulations, 2014 as amended from time to time.

III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in

position.

- 7. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- 8. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -

a. Sanctioned programme(s) along with annual intake in the institution:

- e. Fee charged from students.
- f. Available infrastructural facilities.

g. Facilities added during the last quarter.

h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.

i. The affidavit with enclosure submitted along with application.

- j. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 11. The institution shall make available the list of students admitted on its official website.
- 12. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
