CONTINUATION ORDER

WHEREAS, the recognition was granted to the institution namely, K.M.G. College of Education, No.1, Railway Station Road, Ammankuppam, Gudiyattam, Vellore District-635803, TamilNadu vide SRC (NCTE) order no.F.SRO/NCTE/B.Ed./2006-2007/9182 dated 13.11.2006 for Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 07.01.2015 & for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 05.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 388th meeting held on 14th 15th September 2020 has considered the matters and the Committee decided to issue Show Cause Notice in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents. Accordingly, a Show Cause Notice was issued to the institution on 08.06.2021. The institution vide letter dated 24.06.2021 has submitted reply to the Show Cause Notice.
- **4. AND WHEREAS,** the matter was placed before the SRC in its 400th meeting held on 13th 14th July 2021 and the Committee decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution K.M.G. College of Education, Survey No. 14/3A, at No. 1, Railway Station Road, Ammankuppam Panchayat, Gudiyattam Taluk, Vellore District-635803, TamilNadu for B.Ed. programme for 2 basic units of 50 students each".

5. NOW THEREFORE, this order is issued permitting the institution i.e. K.M.G. College of Education, Survey No. 14/3A, at No. 1, Railway Station Road, Ammankuppam Panchayat, Gudiyattam Taluk, Vellore District-635803, TamilNadu run by Kunja Kousalya Ammal Govundarajan Educational & Charitable Trust, Vellore District-635803, TamilNadu for

Continuation of recognition for B.Ed. programme for 2 basic units of 50 students each subject to fulfilment of the following conditions:

 The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **6.** Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 7. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8.  - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
