WHEREAS, the recognition was granted to the institution namely Rabindranath Tagore College of Education for Women, Veerachipalayam Vilalge, Somkeri West, Sankari Taluk, Salem District, Tamilnadu-637303 vide SRC (NCTE) order no. F.TN/SEC/159/SRO/NCTE/ 2004-2005/894 dt. 24.02.2005 for conducting (B.Ed.) course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 22.01.2015 for its willingness for adherence of provisions of new Regulations. The Revised Provisional Recognition Order was issued to the institution on dt. 08.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 388th Meeting held on 14th & 15th Sep 2020 considered the matter and decided to issue another SCN u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observation noted by the regional Committee. Accordingly, as per decision of SRC a Show Cause Notice was issued to the institution on 08.06.2021. Thereafter, the institution has submitted its reply on dt. 30.06.2021.
- AND WHEREAS, the matter was placed before the SRC in its 400th meeting held on 13th 14th July 2021 and the Committee decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Rabindranath Tagore College of Education for Women, Survey No. 27/1A3, 1A4, 1B3, 1B4, 1C3, 2B2, 2B4, 27/2C1, 2D1, 3A,3C,3B,4 Veerachipalayam Village, Sankagiri Taluk, Salem District-637303, Tamilnadu for B.Ed. programme for 2 basic units of 50 students each."

5. NOW THEREFORE, the SRC decided to permit the institution i.e., Rabindranath Tagore College of Education for Women, Survey No. 27/1A3, 1A4, 1B3, 1B4, 1C3, 2B2, 2B4, 27/2C1, 2D1, 3A,3C,3B,4 Veerachipalayam Village, Sankagiri Taluk, Salem District-637303, Tamilnadu for continuation of recognition for B.Ed. programme for two year duration 2 basic units (50 students each) subject to fulfilment of the following conditions:-

I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

II. The institution shall comply with the various other norms and standards prescribed

in the NCTE Regulations, 2014 as amended from time to time.

III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 6. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- 7. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:

 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
