## TO BE PUBLISHED IN GAZETTE OF INDIA PART III SECTION 4 WITHDRAWAL ORDER

WHEREAS, recognition u/s14 Act of NCTE, 1993 was granted to the institution namely, Jesus & Mary College of Education, D.No. 12-79, Sowbhagyarayapuram Village, Pendurthi Mandal, Vishakhapatnam District-530024 Andhra Pradesh vide order no. F.SRC/NCTE/2009/B.Ed/RO/13325 dt. 29.05.2009 for conducting Secondary B.Ed. Course of one year duration with an annual intake of 100 students.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution had consented to come under new Regulations vide a notarized affidavit dated 22.01.2015. A provisional revised recognition order was issued on 19.03.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 363<sup>rd</sup> meeting held on 17<sup>th</sup> 19<sup>th</sup>September, 2018 has considered the matter and decided to issue Show Cause Notice. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 12.10.2018. The institution has submitted reply on 16.11.2018.
- **4. AND WHEREAS,** the SRC in its 366<sup>th</sup> meeting held on  $03^{rd} 04^{th}$  December 2018 has considered the matter and decided to issue a letter. Accordingly, as per the decision of SRC a letter was issued to the institution on 05.09.2019.
- 5. AND WHEREAS, the SRC in its 381st Meeting held on 31st October & 01st November, 2019 decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report accompanied with the requisite documents. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 15.11.2019. The institution has not submitted reply to the Final Show Cause Notice.
- **6. AND WHEREAS** the SRC in its 411<sup>th</sup> meeting held on 23<sup>rd</sup> 24<sup>th</sup> May 2022 has considered and the following observations were made:

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution failed in submission of reply of Final Show Cause Notice dated 15.11.2019.

Hence the recognition granted to Jesus & Mary College of Education, D.No. 12-79, Sowbhagyarayapuram Village, Pendurthi Mandal, Vishakhapatnam District, Andhra Pradesh for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next academic session i.e. 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counseling / making admissions from the next academic session i.e. 2023-2024.

- 7. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Jesus & Mary College of Education, D.No. 12-79, Sowbhagyarayapuram Village, Pendurthi Mandal, Vishakhapatnam District-530024 Andhra Pradesh for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (two basic units) with effect from the academic session i.e., 2023-2024 onwards. Further, on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate for counseling from the academic session i.e., 2023-2024 and the institution is also not permitted to take any fresh admission of students from the academic session 2023-2024.
- 8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

**9.** Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
