WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Al-Madina College of Education, No. 2-1/1, Keshawajpally Village, Thipparty Mandal, Nalgonda-508001, Andhra Pradesh run by Al-Madeena Educational Society, Door No. 5-9-80, Manyamchalka Street, Nalgonda, Andhra Pradesh vide (NCTE) Order No. F. SRO/NCTE/B.Ed/2011/28075 dated 11.04.2011 for conducting Secondary B.Ed. Course of one-year duration with an annual intake of 100 students from the academic session 2011-12.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 21.02.2015 for its willingness & adherence of provisions of new Regulations. A Revised Provisional Recognition Order (RPRO) was issued to the institution on 19.03.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the management of the institution had requested on 02.03.2016 for one basic unit of 50 students for B.Ed. course. A corrigendum no. SRO/NCTE/ APS09727/B.Ed./TS /2017-18/94085 dated 21.07.2017 was issued to the institution for conducting B.Ed. programme of two-years duration with an annual intake of 50 for one basic unit of 50 students.
- 4. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the RPRO, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice was issued to the institution on 26.02.2019 The management of the institution has submitted on 01.04.2019 its reply to the Show Cause Notice.
- **5. AND WHEREAS** The SRC in its 377th Meeting held on 03rd& 04thJuly, 2019 considered the matter and decided to issue Final Show Cause Notice Accordingly, Final Show Cause Notice was issued on 17.07.2019. The management of the institutions vide letter dated 25.07.2019 & 16.11.2019 submitted replies to the Final Show Cause Notice
- **6. AND WHEREAS**, the SRC 389th Meeting held on 12th& 14thOctober, 2020 decided to issue last reminder letter. Accordingly, as per decision a Last Reminder Letter was issued to the institution on 16.10.2020. The management of the institution has submitted reply of Last Reminder Letter on 04.12.2020.
- 7. **AND WHEREAS**, the SRC in its 405th Meeting held on 13rd & 14th December, 2021 considered the matter and decided to withdraw the recognition to the institution. Accordingly, a withdrawal Order no. F.SRO/NCTE/APSO9727/B.Ed. /TS/2021/129771 was issued on 31.12.2021.

8. AND WHEREAS, the institution has filed Writ Petition before Hon'ble High Court of Delhi for both courses bearing W.P (C) No. 15039/2022 & CM APPLs. 46431/2022 titled as Al-Madina College of Education Versus National Council for Teacher Education Whereby the Hon'ble High Court has directed that: -

"Petitioner to participate in counselling and admit students for academic session 2022-23. The NCTE is directed to reflect the status of the Petitioner as a recognised institution for the year 2022-23 on its website and send an intimation to Petitioner's affiliating university and concerned State Government. The above direction shall be carried out within one week from today.

The Appellate Committee of NCTE shall also endeavor to dispose of Petitioner's appeal as expeditiously as possible, not later than three months from today."

- 9. AND WHEREAS, in compliance of order dated 31.10.2022, the Regional Director, SRC has already passed an order dated 25.11.2022 no. File No.SRO/NCTE/APSO9727/B.Ed./TS /2022/137591-137593 regarding entitlement to participate in the Counselling for academic session 2022-2023.
- 10. AND WHEREAS, the SRC 417th in its meeting held on 1st & 2nd December 2022 considered the matter and Committee decided as under:-

In Compliance of order dated 31.10.2022 passed by the Hon'ble High Court of Delhi at New Delhi in W.P (C) No. 15039/2022 titled as Al-Madina College of Education versus NCTE & Anr., the Regional Director has issued order dated 25.11.2022, wherein the institution is permitted to participate in process of counselling for the academic session 2022-2023. While ratifying the decision taken by the Regional Director the Committee directed the office of the RD to write a letter to the Affiliating University to ensure that the institution has complied with NCTE Regulations, 2014 or not. The Registrar of the affiliating university be requested to send a compliance report in this regard."

- 11. AND WHEREAS, According, a letter dated 13.12.2022 was issued to The Registrar Mahatma Gandhi University Nalgonda.
- 12. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-66/E-244305/2022 Appeal/9th Meeting, 2022 APPLSRC202214294 dated 05.12.2022 appeal remand back the order appealed against. The institution vide letter dated 07.12.2022 submitted reply to the appeal remand back order
- 13. AND WHEREAS, the SRC in its 418th meeting held on 16th December 2022 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Al-Madina College of Education, Survey No. 120, 40, Plot No. 2-1/1, Keshawahpally, Thipparty Mandal, Nalgonda-508001, Telangana for B.Ed. programme for 1 basic unit of 50 students."

- 14. NOW THEREFORE, this order is issued permitting the institution i.e. Al-Madina College of Education, Survey No. 120, 40, Plot No. 2-1/1, Keshawahpally, Thipparty Mandal, Nalgonda-508001, Telangana for continuation of recognition for B.Ed. Programme for two years duration (1 basic unit) of 50 students subject to fulfillment of the following conditions:-
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 15. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- **16.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 17. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- i. The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- **18**. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 19. The institution shall make available the list of students admitted on its official website.
- 20. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
