WHEREAS, the recognition u/s 14 (3) (a) of NCTE Act, 1993 was granted to the institution namely Pallavi College of Education, Pargi, Ranga Reddy District-501501, Andhra Pradesh vide (NCTE) order No. F.AP/NEW/B.Ed./28/SRO/NCTE/2002-2003/2932 dated 11.10.2002 for conducting B.Ed. Course of one-year duration with an annual intake of 100 students from the academic session 2002-2003.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 21.01.2015 for its willingness & adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 14.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 388th meeting held on 14th 15th September 2020 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the requisite documents/VT report accompanied with the requisite documents. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 13.04.2021. The institution vide letter dated 23.06.2021 has submitted a reply in response to the Show Cause Notice.
- 4. AND WHEREAS, the SRC in its 409th meeting held on 29th and 30th March 2022 considered the matter and committee decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 18.04.2022. the institution has submitted reply of Final Show Cause Notice vide letter dated 01.07.2022.
- **6. AND WHEREAS**, the SRC in its 417th meeting held on 1st & 2nd December 2022 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Pallavi College of Education, Door No. 9-329 (New), 10-23/2, (Old), Survey No.294/A, Pargi (Village & GP), Pargi (Mandal), Vikarabad District, 501501, Telangana for B.Ed. programme, 2 basic units of 50 students each."

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

- Further, the institution is required to fulfill all such other requirements as may be 8. prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 10 The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter - alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. - 12. The institution shall make available the list of students admitted on its official website.
- 13. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
