WHEREAS, the recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, Sri Vivekananda D.P.Ed. College, Plot/Khasra No.18/1, 213/4, 196/2, 197/3, 446/2, Plot No. 11-387, podili Village and Post Office, Podili Taluk and Town, Prakasam District-523240, Andhra Pradesh vide order No. F. SRO/SRCAPP15020/D.P.Ed./AP/2016/84812 dated 02.05.2016 for conducting D.P.Ed. programme of two year duration with an annual intake of 100 students from the academic session 2016-2017.

- 2. AND WHEREAS, the SRC in its 413th meeting held on 22nd 23rd August 2022 discussed the matter about the institutions who failed to submit the PAR a advised by the NCTE and directed to the Regional Director, SRC to serve a Show Cause Notice to failure of submitting the PAR to all such institutions seeking infrastructure and instructional details along with GIS location at the earliest. Accordingly, as per the decision of SRC, a Show Cause Notice was issued to the institution on 01.12.2022.
- **3. AND WHEREAS,** a letter dated 31.12.2022 has submitted by the institution for closure of D.P.Ed. Programme and stated as under: -

"Kind attention to the Minutes of the SRC Hold on 418th meeting - 16th December 2022, the Committee considered the Representation submitted and decided to constitute the online Visiting Team for inspection section 13 of infrastructural & instructional facilities etc.

As per the above reference, at present we are running D.P.Ed, B.P.Ed and B.P.Ed - Al colleges with sufficient infrastructural facilities. Due to poor admissions in D.P.Ed., we want to close the D.P.Ed course and to continue both B.P.Ed and B.P.Ed -Al.

We humbly request SRC to kindly issue Continue of Recognition to our Sri Vivekananda B.P.Ed College, Plot No. 18/1, 213/4, 196/2, 197/3, 446/2,

- 4. **AND WHEREAS**, the SRC in its 422nd meeting held on 02nd 03rd March, 2023 considered the matter and decided to withdraw the recognition order. Accordingly, as per the decision of SRC a withdrawal order issued to the institution on 21.03.2023.
- 5. AND WHEREAS, the institution has filed a WP. NO. 121 of 2024 in the Hon'ble High Court of Andhra Pradesh at Amaravati, whereby the Hon'ble High Court vide its order dated 05.02.2024 has directed that: -
 - "...9. Even otherwise, since learned counsel for the petitioner restricted the relief only to consider the representation of the petitioner, instead of going into the merits of the case, this Court feels it appropriate to dispose of the writ petition directing the 2nd respondent to dispose of the representations dated 13.12.2023 and 21.06.2023 made by the petitioner and pass appropriate orders, in accordance with law.

10. with the above direction, the Writ Petition is disposed of. There shall be no order as to costs."

6. AND WHEREAS, The SRC in its 443rd meeting held on 19th – 20th September, 2024 considered the matter and decided as under: -

"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

In accordance with the Court Order dated 05.02.2024, the committee has taken note of the directions issued by the Hon'ble High Court of Andhra Pradesh.

Accordingly, the committee has decided to formally inform the institution to provide the representations dated 13.12.2023, and 21.06.2023, along with acknowledgement of the submission of the aforementioned documents to the NCTE so the same can be put up in for consideration in next SRC Meeting."

Accordingly, as per the decision of SRC a letter was issued to the institution on 08.10.2024." The institution has submitted a reply received on 09.10.2024.

7. AND WHEREAS, the SRC in its 444th meeting held on 15th – 16th October, 2024 considered the submitted representation dated 13.12.2023 by the Institution and decided that the request for continuation order is hereby rejected. Accordingly, as per the decision of SRC, a letter was issued to the institution on 20.11.2024.

- **8. AND WHEREAS,** aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-86/E-351353/2024 Appeal/3rd Meeting 2025 dated 16.04.2025 appeal remand back the order appealed against.
- **9. AND WHEREAS,** the Registrar, Andhra Kesari University vide letter dated 25.04.2025 has submitted documents submitted by the institution after verification. The institution has submitted documents as per the directions of appellate authority on 26.04.2025.
- **10. AND WHEREAS**, the SRC in its 461st meeting on 26th-27th May 2025 considered the reply submitted by the institution and decided as under: -

"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

1. The SCN reply submitted by the institution on 26.04.2025 found to be satisfactory.

Hence, the Committee decided that the continuation order be issued to the Institution namely Sri Vivekananda D.P.Ed. College, Plot/Khasra No.18/1, 213/4, 196/2, 197/3, 446/2, Plot No. 11-387, Podili Village and Post Office, Podili Taluk and Town, Prakasam District-523240, Andhra Pradesh for D.P.Ed. programme of 2 basic unit of 100 students."

- 11. NOW THEREFORE, as per the decision of SRC, this order is issued permitting the institution i.e., Sri Vivekananda D.P.Ed. College, Plot/Khasra No.18/1, 213/4, 196/2, 197/3, 446/2, Plot No. 11-387, Podili Village and Post Office, Podili Taluk and Town, Prakasam District-523240, Andhra Pradesh for Continuation of recognition for D.P.Ed. programme of 2 basic unit of 100 students subject to fulfilment of the following conditions: -
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- **12.** Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 13. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 14. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - e. Fee charged from students.
 - f. Available infrastructural facilities.
 - g. Facilities added during the last quarter.
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - i. The affidavit with enclosure submitted along with application.
 - i. The institution shall be free to post additional relevant information if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 15. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

- **16.** The institution shall make available the list of students admitted on its official website.
- 17. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
