Accordingly, Show Cause Notice was issued to the institution on 22.6.2011. The institution has submitted written representation on 08.07.2011.

AND WHEREAS, the matter was placed before SRC in its 208th meeting held on 13th and 14th July, 2011 and the Committee decided to issue Letter of Intent (LOI).

Accordingly, Letter of Intent (LOI) was issued to the institution on 20.7.2011. The institution has submitted LOI reply on 18.8.2011, which was placed before SRC in its 211th meeting held on 21st to 23rd September, 2011 and the Committee decided to issue Show Cause Notice.

Accordingly, a Notice was issued to the institution on 02.11.2011. Notice has not been received

Meantime the institution has submitted letter dated 6.2.2012 stated as follows; "...Letter of Intent has been issued to us for the establishment of Sahaya Institute of Advanced Studies in Education vide F.No.SRCAPP462/B.Ed/AP/2011-12/29628 dated 20.7.2011 and as per the conditions laid out in the letter, we vide our letter at ref-I above, have submitted the compliance certificate along relevant documents to enable NCTE to accord formal recognition for the establishment of Sahaya Institute of Advanced Studies in Education for the Academic year 2011-2012.

In this connection, we would like to bring to your kind notice that we are yet get any communication from NCTE regarding the issue of formal recognition for the establishment of Sahaya Institute of Advanced Studies in Education and that we missed to commence operations from the Academic Year 2011-2012 onwards. Necessary copies of the earlier correspondence are enclosed herewith for your reference.

On our visit to your office on 6.2.2012, we were shocked to know that a letter has been dispatched to us during November, 2011 but we inform you that no such letter has been delivered to us and that we are regularly receiving all other communications at our address. In this connection, we request your kind self to provide us a copy of your letter and give a time of around 15-30 days to enable us to submit necessary compliance. Keeping in view the fact that we are minority institute striving for the cause of education by creating all the infrastructure and huge amount of investment, we request you to consider our case sympathetically and kindly do the needful in the matter".

AND WHEREAS, the Committee in its 217<sup>th</sup> meeting held on 08<sup>th</sup>-09<sup>th</sup> February, 2012 considered the request of the institution vide their letter dt.06.02.2012 and decided to give 15 days time to the institution to submit the necessary compliance.

Accordingly, a letter was issued to the institution on 14/02/2012 extending the time for 15 days. The institution has submitted reply on 28/02/2012.

On careful perusal of the original file of the institution and approved staff profiles from the affiliating body, submitted by the institution in response to the letter of Intent, the Regional Committee decided that Formal Recognition be granted to B.Ed., course of one year duration with an annual intake of 100 (One hundred only) students from the academic session 2012-2013 onwards, subject to the rectification of deficiencies in staff list, if any,

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Southern Regional Committee, NCTE hereby grants recognition to Sahaya Institute of Advanced Studies in Education, Plot No. 199-3, Kotramangalam Village, Tiruchanoor Post Office, Renigunta Taluka, Tirupati City, Chittoor District - 517 503, Andhra Pradesh (SRCAPP462) for conducting B.Ed Course of one year duration with an annual intake of 100 (One hundred only) students from the academic session 2012-2013 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject, to fulfillment of the following conditions:

- The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account I. with SRC, NCTE should be maintained always. Loan raising or mortgaging of FDRs shall not be done.
- The institution shall comply with the various other norms and standards prescribed in the II. NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining III. body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.
- The institution shall ensure that the required number of academic staff for conducting the IV. course is always in position.
- V. The institution shall declare themselves as minority trust and minority institution proposed to be established.
- The institution/Management shall produce valid minority certificate from the notified VI. authority of the respective State Government on or before 31st March, 2013, failing which, the institutions shall be de-recognized automatically without any further notice and that such institutions shall make no further admission thereafter.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
