**SHIFTING ORDER**

**WHEREAS**, recognition u/s14 NCTE Act, 1993 was granted to the institution namely **St. Peter College of Education, Adoni Revenue Division Adoni, Kurnool District-518301, Andhra Pradesh** vide SRC order No. F. AP/New/B.Ed./109/SRO/NCTE/2002-03/611 dt. 03.03.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

**2. AND WHEREAS**, after promulgation of NCTE Regulations, 2014 the institution had consented to come under new Regulations vide a notarized affidavit dated 30.01.2015. A revised provisional recognition order was issued on 30.05.2015 to the institution for conducting B.Ed. programme of two-year duration with an annual intake of 100 students (Two basic units) from the academic session 2015-2016.

**3. AND WHEREAS**, the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 30.04.2019. The institution vide letter dated 12.06.2019 submitted its reply to the show cause notice.

**4. AND WHEREAS**, the SRC in its 382<sup>nd</sup> meeting held on 26<sup>th</sup> – 27<sup>th</sup> November, 2019 considered the matter and decided to constitute the visiting team for inspection of infrastructure & instructional facilities for the B.Ed. course after collecting a fee of Rs 1,50,000/- Accordingly, as per the decision of SRC a letter was issued to the institution on 19.12.2019. The institution vide letter dated 06.12.2019 submitted written representations.

**5. AND WHEREAS**, the SRC in its 412<sup>th</sup> meeting held on 05<sup>th</sup> – 06<sup>th</sup> July 2022 has considered the matter and decided to withdraw the recognition to the institution. Accordingly, as per the decision of SRC, a Withdrawal Order No.

F.SRC/NCTE/APS00203/B.Ed./AP/2022/132959-132963 dated 25.07.2022 was issued to the institution.

**6. AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-130/E-312000/2023 Appeal/9<sup>th</sup> Meeting, 2023 Appeal No. APPLSRC202314641 dated 12.09.2023 appeal remand back the order appealed against. The institution has submitted a reply to the Appeal Remand Back on 20.09.2023.

**7. AND WHEREAS**, the SRC in its 429<sup>th</sup> Meeting held on 25<sup>th</sup> August, 2023 considered the matter and decided to constitute the online Visiting Team for inspection of infrastructural & instructional facilities etc. of **St. Peter College of Education, Survey No. 20-62/1,2,3, Adoni Kurnool District, Andhra Pradesh-518301**. Accordingly, as per the decision of SRC a letter was issued to the institution on 19.10.2023 to submit the shifting fee. The institution has submitted shifting fee vide letter dated 28.10.2023. The institution has submitted VT documents vide letter dated 06.11.2023. The inspection was conducted on 06.05.2025 and VT report received on 08.05.2025.

**8. AND WHEREAS**, the SRC in its 459<sup>th</sup> Meeting held on 08<sup>th</sup> – 09<sup>th</sup> May, 2025 considered the matter and decided to issue Show Cause Notice to the institution. Accordingly, as per the decision of SRC, Show Cause Notice was issued on 15.05.2025. The institution has submitted its reply on 15.09.2025.

**9. AND WHEREAS**, the SRC in its 467<sup>th</sup> meeting held on 23<sup>rd</sup> July, 2025 has considered the matter and decided as under: -

“The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, VT Report, Reply to SCN, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations: -

1. The Committee considered the VT report along with other required documents for shifting of premises and found fit for shifting of premises.

Hence, the Committee decided that the institution **be permitted for shifting of its premises at new address St. Peter College of Education, Survey No. 20-62/1,2,3, Adoni Revenue Division, Kurnool District - 518301, Andhra Pradesh** for B.Ed. programme of two basic units of 50 students each.”

**10. NOW THEREFORE**, as per the decision of SRC, this order is issued permitting the institution i.e., **St. Peter College of Education, Adoni Revenue Division Adoni, Kurnool District-518301, Andhra Pradesh** to shift its building/premises at new address at Survey No. 20-62/1,2,3, Adoni Revenue




**Division, Kurnool District - 518301, Andhra Pradesh** for conducting B.Ed. programme of two basic units of 50 students each.
