SHIFTING ORDER**

WHEREAS, the recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Sri Padmavathi College of Education, Kavali, Nellore District – 524201, Andhra Pradesh vide SRC order, no. F.SRO/NCTE/B.Ed/2007-2008/11120 dated 07.09.2007 for conducting B.Ed. course of one year duration with an annual intake of 100 students.

2. **AND WHEREAS**, on promulgation of NCTE Regulation 2014, the institution has submitted an affidavit dt. 19.01.2015 for its willingness and adherence of provision of new Regulation. Thereafter, the Revised Provisional Recognition Order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.


3. **AND WHEREAS**, the SRC in its 368th meeting held on 08th & 09th January, 2019 considered the matter and decided to issue SCN: Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 16.01.2019. The institution vide letter dated 20.01.2019 submitted reply to the show cause notice.

4. **AND WHEREAS**, again, the SRC in its 374th meeting held on 09th – 10th April, 2019 considered the matter and decided to issue Show Cause Notice. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 22.04.2019.

5. **AND WHEREAS**, the SRC in 381th meeting held on 31st Oct & 1st Nov, 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Repost accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, a Final Show Cause Notice was issued to the institution on 29.11.2019. The institution vide letter dated 17.12.2019 submitted its reply to the Final Show Cause Notice.

6. **AND WHEREAS**, the SRC in its 389th meeting held on 12th & 14th October, 2020 considered the matter and decided to issue a last reminder letter. Accordingly, as per the decision of SRC a last reminder letter was issued to the institution on 23.10.2020.

7. **AND WHEREAS**, the institution has submitted an application along with processing fee i.e 1,77000/- of shifting premises on 05.05.2025. The SRC in its 459th meeting held on 08th – 09th May, 2025 considered the matter and decided to constitute online VT for shifting of premises of the institution.



8. AND WHEREAS, the online inspection was conducted on 12.08.2025 and VT report received on 18.08.2025. The SRC in its 470th meeting held on 20th August, 2025 considered the VT report and decided as under:-

"The original file of the Institution along with other related documents, NCTE Act 1993, Regulations, VT Report, Reply to SCN, Guidelines issued by NCTE from time to time, the SRC after careful consideration made the following observations:-

1. *The Committee considered the VT report along with other required documents for shifting of premises and found fit for shifting of premises.*

Hence, the Committee decided that the institution be permitted for shifting of its premises at new address Sri Padmavathi College of Education, Survey No. 108, Main Road, Balighattam, Narsipatnam, Anakapalli, Andhra Pradesh - 531116 for B.Ed programme of two basic units of 50 students each."

9. NOW THEREFORE, the permission is hereby accorded by the SRC, NCTE to shift its premises to the new location/building at Sri Padmavathi College of Education, Survey No. 108, Main Road, Balighattam, Narsipatnam, Anakapalli District, Andhra Pradesh - 531116 from the old premises i.e. Sri Padmavathi College of Education, Kavali, Nellore District – 524201, Andhra Pradesh.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition ad under the provisions of Section 17(1) of the NCTE Act.
