WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely Aazad College of Education, Plot no. 252/1, 2, O.V.Road, Oguru Village, Kandukur, Prakasam District, Andhra Pradesh-523105 run by S.R. Educational & Rural Development Society, Kandukur, Prakasam District, Andhra Pradesh vide order no. F.SRO/NCTE/B.Ed./2011/26462 dt. 25.01.2011 for conducting secondary B.Ed. course of one year duration from the academic session 2011-2012 with an annual intake of 100.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 17.01.2015 for its willingness of one unit in B.Ed. course and adherence of provisions of new Regulations. Thereafter, a Revised Provisional Recognition Order was issued to the institution on 13.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 Students each (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in 388th Meeting held on 14th & 15th September 2020 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Repost accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, Show Cause was issued on 07.01.2021. The institution submitted its reply on 20.01.2021.
- 4. AND WHEREAS, the SRC in its 399<sup>th</sup> meeting held on 15<sup>th</sup> 16<sup>th</sup> June 2021 has considered the matter and decided to issue a continuation order to the institution. Accordingly, as per the decision of SRC, an order No.F.No.SRC/NCTE/AP/SRCAPP110/B.Ed./2021/126927-126933 was issued to the institution on 01.07.2021.
- 5. AND WHEREAS, a letter dated 28.03.2022 was received from the institution to request for Shifting permission at new location i.e., S.No.111/1A, Guntur Road, Amaravathi-522020, Guntur District, Andhra Pradesh in the same university "Acharya Nagarjuna University, Guntur, Andhra Pradesh along with DD No.828143 of Rs. 150000/- in favour of Member Secretary, NCTE, New Delhi, Application for Shifting of premises and all necessary enclosures.
- 6. AND WHEREAS, the SRC in its 410<sup>th</sup> meeting held on 25<sup>th</sup> 26<sup>th</sup> April 2022 considered the matter and decided to constitute the Visiting Team for shifting of premises for inspection of infrastructure & instructional facilities. The VT was conducted on 09.05.2023. The VT Report was received on 11.05.2022. The institution has also submitted a letter along with support documents wherein received on 11.05.2023.

7. AND WHEREAS, the SRC in its 425<sup>th</sup> meeting held on 18<sup>th</sup> May, 2023 has considered the VT report and decided as under:-
