WHEREAS, permission u/s15 of NCTE Act, 1993 was granted to the institution namely. K.L.N. Teachher Training Institute, Kozhimedu, Viraganoor Post, Madurai District-625009, TamilNadu run by K.L.Nagaswamy Memorial Sourashtra Polytechnic Council. Madurai District, TamilNadu vide SRC (NCTE) order no. F.SRO/NCTE/D.T.Ed./2007-2008/18802 dt.14.03.2008 for conducting D.T.Ed. (Elementary) Course of two years duration with an annual intake of 50 students.

- AND WHEREAS, the letter dated 11.06.2022 has submitted a written representation requesting to close the institution.
- AND WHEREAS, the SRC in its 412th Meeting of SRC held on 05th 06th July 2022 considered the matter and requesting to close the institution and decided as under: -

"The original files of the Institution along with other related documents, NCTE Act, 1993. Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee agreed to close down the institution as requested by the Management vide dated 11.06.2022 by withdrawing the recognition granted to K.L.N. Teachher Training Institute, Kozhimedu, Viraganoor Post, Madurai District-625009, TamilNadu for conducting D.T.Ed. Programme under clause 17(1) of NCTE Act. 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in this meeting".

- NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to closed down the institution by withdrawing recognition granted to K.L.N. Teachher Training Institute, Kozhimedu, Viraganoor Post, Madurai District-625009, TamilNadu run by K.L.Nagaswamy Memorial Sourashtra Polytechnic Council, Madurai District, TamilNadu for conducting D.T.Ed. Programme of two years duration with an annual intake of 50 students with effect from the academic session i.e., 2023-2024 onwards as requested.
- Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained
