WHEREAS, the recognition u/s 14 of NCTE Act. 1993 was granted to the institution namely Jai Sairam College of Education, Plot No. 390/3B, 390/7, 390/2, 390/6, Palavanatham Village & Post Office, Aruppukottai Taluk, Virudhunagar City & District-626004, Tamilnadu run by Sri Venkateswa Educational Trust, Plot No. 3-243/300, G.S.T. Road, Thanakakulam Village & Post Office, Thiruparangkundram Taluk, Madurai City & District-625006, Tamilnadu vide SRC (NCTE) order F.SRO/NCTE/SRCAPP14931/B.Ed./TN/2016-2017/84950 dated 02.05.2016 for conducting Secondary B.Ed. Programme of two-years duration with an annual intake of 100 students from the academic session 2016-2017.

- 2. AND WHEREAS, the SRC in 388<sup>th</sup> Meeting held on 14<sup>th</sup> & 15<sup>th</sup> November 2020 considered the matter and decided to issue SCN in all such matters where the institution has not submitted requisite documents/VT Repost accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, as per decision of SRC Show Cause was issued to the institution 24.09.2020. The institution has not submitted reply to the Show Cause Notice.
- 3. AND WHEREAS, the SRC in its  $409^{th}$  meeting held on  $29^{th}-30^{th}$  March 2022 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 19.04.2022. The institution has not submitted any reply to the Final Show Cause Notice.
- 4. AND WHEREAS, the SRC in its 412<sup>th</sup> Meeting held on 05<sup>th</sup> & 06<sup>th</sup> July 2022 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

(i) The institution failed to submit reply to the Final Show Cause Notice dated 19.04,2022.

Hence the recognition granted to Jai Sairam College of Education, Plot No. 390/3B, 390/7, 390/2, 390/6, Palavanatham Village & Post Office, Aruppukottai Taluk, Virudhunagar City & District-626004, Tamilnadu for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next academic session i.e. 2023-2024. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counselling / making admissions from the next academic session i.e. 2023-2024."

5. NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Jai Sairam College of Education, Plot No. 390/3B, 390/7, 390/2, 390/6, Palavanatham Village & Post Office, Aruppukottai Taluk,

Programme with effect from the academic session i.e. 2023-2024 onwards. further on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate in counseling / making admissions from the academic session i.e. 2023-2024.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
