WITHDRAWAL ORDER

WHEREAS, recognition u/s14 Act of NCTE, 1993 was granted to the institution namely, **Sir CRR College of Education, Opp. to S.P. Bungalow, N.H. 5, Eluru-534007, West Godavari District, Andhra Pradesh** vide order No. F.AP/B.Ed/21/SRO/NCTE/2000-01/1275 dated 19.07.2000 for conducting Secondary (B.Ed.) Course of one year duration with an annual intake of 75 students and F.SRO/NCTE/2001-2002/7898 dated 18.09.2021 for an intake of 160 students.

2. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the institution had consented to come under new Regulations vide a notarized affidavit dated 31.01.2015. A revised provisional recognition order was issued on 06.05.2015 to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.

3. **AND WHEREAS**, on the basis of request, the SRC in its 342nd meeting held on 5th – 6th July, 2017 decided for reduction of intake from 2 units to 1 unit. Accordingly, a order was issued to the institution for reduction of intake from 2 units to 1 unit on dated 08.08.2017.

4. **AND WHEREAS**, the SRC in its 369th meeting held on 28.01.2019 and the Committee decided to that the Show Cause Notice be issued to all such institution which have not submitted compliance. Accordingly, as per the decision of SRC, a Show Cause Notice issued on 13.05.2019. The institution has submitted reply received on 14.06.2019.

5. **AND WHEREAS**, the SRC in its 381st meeting held on 31st Oct & 01st Nov, 2019 considered the matter and decided to issue Final Show Cause Notice. Accordingly, a Final Show Cause Notice issued to the institution on 08.11.2019.

6. **AND WHEREAS**, the SRC in its 394th meeting held on 27th -28th January 2021 considered the matter and decided to issue last reminder letter. Accordingly, as per decision of SRC a last reminder letter was issued to the institution on 15.03.2021. The institution has not submitted reply to the last reminder letter.

7. **AND WHEREAS**, the SRC in its 412st meeting held on 05th -06th July 2022 has considered the matter and the following observations were made:

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

- (i) The institution was issued a Last Reminder Letter on 15.03.2021. The institution failed to submit reply along with the requisite documents/information to the Last Reminder Letter. The Committee also

noted that the institution has not even filed Performance Appraisal Report (PAR).

Hence the recognition granted to **Sir CRR College of Education, Opp. to S.P. Bungalow, N.H. 5, Eluru-534007, West Godavari District, Andhra Pradesh** for **B.Ed. course** is withdrawn under Section 17(1) of NCTE Act, 1993 from the end of next academic session i.e. **2023-2024**. On withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to participate in counselling / making admissions from the next academic session i.e. **2023-2024**.

8. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Sir CRR College of Education, Opp. to S.P. Bungalow, N.H. 5, Eluru-534007, West Godavari District, Andhra Pradesh** for conducting **B.Ed. Programme** of two years duration with an annual intake of **50 students (one basic unit)** with effect from the end of next academic session i.e., **2023-2024**. Further, *on withdrawal of recognition, the affiliation if any granted under Clause 8(10) of NCTE Regulation, 2014 by the concerned affiliating body from the academic session stands withdrawn. Hence, the institution is not entitled to participate for counseling from the academic session i.e., 2023-2024 and the institution is also not permitted to take any fresh admission of students from the academic session 2023-2024.*

7. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
