WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely, **Mother Terasa College of Education for Women, Mettusalai, Illupuram Post, Pudukottai, Tamilandu-622102** run by **Mother Terasa Educational Charitable Trust, Tamilnadu** vide SRC vide order no. F.SRO/NCTE/B.Ed./2006-2007/7416 dt. 01.09.2006 for Secondary (**B.Ed.**) course of one-year duration with an annual intake of 100 students from the academic session 2006-2007.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 27.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 17.03.2015 for conducting **B.Ed. programme** of two years duration with an annual intake of **100 students for two basic units** from the academic session 2015-16.

3. **AND WHEREAS**, on the basis of request, the SRC in its 343rd meeting held on 01st – 02nd July, 2017 decided for reduction of intake from 2 units to 1 unit. Accordingly, a order was issued to the institution on 05.10.2017 reduction of intake from 2 units to 1 unit.

4. **AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 16.08.2019. The institution has submitted reply on 05.09.2020.

5. **AND WHEREAS**, the SRC in its 384th meeting held on 12th - 13th February 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 10.08.2020. The institution has submitted reply received on 16.09.2020.

6. **AND WHEREAS**, the SRC in its 402nd Meeting held on 13th & 14th September, 2021 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 16.09.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

"Vide Final Show Cause Notice dt. 10.08.2020 the institution was directed to submit the documents and information on 13 points. The institution submitted its reply vide letter dt. Nil received on 16.09.2020 inter-alia requesting to run the B.Ed. course with one unit of 50 students only. The institution has mentioned that "since there is no admission in our institution due to non-availability of eligible students, we are not creating any additional

infrastructure and instruction facilities for two basic units of 50 each as per the Teacher Education Regulation 2014...."

Clause 8(12) of NCTE Regulation is reproduced below: -

"The institution shall make the information or documents available to the Council or its authorized representatives as and when required by them and failure to produce or show any of the required documents, shall be treated as a breach of the conditions of recognition."

The institution has failed in submission of documents directed to be submitted vide Final Show Cause Notice dt. 10.08.2020 and is treated as a breach of the conditions of recognition.

*Hence, the Committee decided to **withdraw the recognition** granted to **Mother Terasa College of Education for Women, Mettusalai, Illupuram Post, Pudukottai, Tamilandu-622102** for conducting **B.Ed. programme** with effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."*

7. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Mother Terasa College of Education for Women, Mettusalai, Illupuram Post, Pudukottai, Tamilandu-622102** run by **Mother Terasa Educational Charitable Trust, Mettusalai, Illuppur (Post), Puddukkottai District, Tamilandu-622102** for conducting **B.Ed. programme** of two years duration with an annual intake of **50 students (1 basic unit)** with effect from the academic session i.e., 2021-2022 onwards.

8. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

9. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
