WHEREAS, the recognition was granted to the institution namely, Bapuji College of Physical Education, BIET Campus, Davanagere, Karnataka-577004 run by Bapuji Educational Association, Davanagere, Karnataka vide SRC vide order no. F.SRO/NCTE/B.P.Ed./2005-2006/3375 dt. 10.10.2005 for B.P.Ed. course of one year duration from the academic session 2005-2006 with an annual intake of 50 students.

- 2. AND WHEREAS, the SRC in its 253rd meeting held on 30th September & 01st October considered the matter and decided to withdraw the recognition. Accordingly, as per decision of SRC withdrawal order no. F.SRO/NCTE/APSO2155/B.P.Ed./KA/2013-14/55409 dt. 13.12.2013 issued to the institution.
- 3. AND WHEREAS, an order vide no. F.SRO/NCTE/APS02155/B.P.Ed./KA/2014-2015/61413 dt. 30.01.2015 recognition accorded to the Bapuji College of Physical Education, S.S. Layout, 'A' Block, Lake View Campus, Davangere, Karnataka 577004 for B.P.Ed. course is hereby restored/continued till further order. The institution is permitted to shift from B.I.E.T. Campus, Davangere, Karnataka to S.S. Layout 'A' Block, Lake View Campus, Davangere, Karnataka-577004.
- 4. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 01.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 31.05.2015 for conducting B.P.Ed. programme of two years duration with an annual intake of 100 students for one basic unit from the academic session 2015-16.
- 5. **AND WHEREAS**, the SRC in its 369th meeting held on 28.01.2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted compliance of the revised recognition order. Accordingly, as per decision of SRC Show Cause was issued to the institution on 16.05.2019. The institution did not submit reply to the Show Cause Notice.
- **6. AND WHEREAS**, the SRC in its 388th meeting held on 14th-15th September 2020 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC Final Show Cause Notice was issued to the institution on 09.10.2020. The institution has submitted reply on 05.10.2020.
- 7. **AND WHEREAS**, the SRC in its 402nd Meeting held on 13th & 14th September, 2021 considered the FSCN reply matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 05.10.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution did not submit building plan duly approved by the competent authority.
- 2. The institution has not submitted a copy of proforma of faculty for all the staff members and the same is also not approved by the affiliating body.
- 3. The institution submitted self-attested copy of land documents. The institution did not submit certified / notarized copy of land documents.
- 4. The institution did not submit an Affidavit (in original) on Rs. 100/- stamp paper as required under 8(5) of NCTE Regulations, 2014.
- 5. The institution did not submit Notarized English translation of Non-Encumbrance Certificate.
- 6. The Building Completion Certificate is not under prescribed format and also is not approved by the competent authority.
- 7. Form 'A' signed by the bank in respect of maintenance of FDRs for Endowment and Reserve Fund has not been submitted.
- 8. Website of the institution is not functional with upload the information required under clauses 8(6), 8(14) and 10(3) of NCTE Regulations, 2014.
- 9. The institution did not submit documents related to managing society / trust.
- 10. Details of other courses being run in the same premise have not been submitted.

Hence, the Committee decided to withdraw the recognition granted to Bapuji College of Physical Education, BIET Campus, Davanagere, Karnataka-577004 for conducting B.P.Ed. programme with effect from the academic session i.e., 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

- 8. NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Bapuji College of Physical Education, S.S. Layout 'A' Block, Lake View Campus, Davangere, Karnataka-577004 run by Bapuji Educational Association, S.S. Layout 'A' Block, Lake View Campus, Davangere, Karnataka-577004 for conducting B.P.Ed. programme of two years duration with an annual intake of 100 students (1 basic unit) with effect from the academic session i.e., 2021-2022 onwards.
- **9.** Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central

Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

10. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
