WHEREAS, the recognition was granted to the institution namely Sri Ankala Reddy Memorial College of Education, Alagadda - 518543, Kurnool District . Andhra Pradesh vide SRC (NCTE) order no. F.AP/B.Ed/43/SRO/NCTE/2000-2001/9114 dated 24.12.2001 for B.Ed. course of one-year duration from the academic session 2001-2002 with an annual intake of 140 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dated 27.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 30.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 150 (Three basic units) from the academic session 2015-16.

AND WHEREAS, the SRC in its 314th meeting held during 27th & 28th May, 2016 decided ask to VT. Accordingly, as per the decision of SRC, a VT letter was issued to the institution on 14.06.2016.

AND WHEREAS, the SRC in its 318th Meeting held on 8th and 9th August 2016 considered the matter and decided to issue Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 28.09.2016.

AND WHEREAS, the SRC in its 388th meeting held on 14th-15th September, 2020 considered the matter committee decided issue Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 07.01.2021. The institution has submitted reply vide dated 30.1.2021 in response to the Final Show Cause notice.

AND WHEREAS, the SRC in its 399th meeting held on 15th & 16th June 2021 considered the matter and decided to issue Last Reminder Letter. Accordingly, as per the decision of SRC a last reminder letter was issued to the institution on 01.07.2021. The institution has submitted reply of last reminder letter on 12.07.2021.

AND WHEREAS, the SRC in its 400th meeting held on 13th – 14th July 2021 considered the matter and decided to issue Last Reminder Letter. Accordingly, as per the decision of SRC a last reminder letter was issued to the institution on 06.08.2021. The institution has submitted reply of last reminder letter on 11.08.2021.

AND WHEREAS, the SRC in its 402nd Meeting held on 13th -14th September, 2021 considered the matter and decided as under:-

The institution has submitted its reply on 11.08.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institution submitted the photocopy of proforma of 16 faculty signed by the Registrar on 02.07.2021 for B.Ed. programme and 11 faculty for M.Ed. course but the date of joining of faculty has not been mentioned.
- 2. The institution was directed to submit the copies of pass book certified by the bank establishing the fact that the salary to faculty is being disbursed through bank account but the same has not been submitted.
- 3. The institution submitted a copy of LUC signed by the Tehsildar on 22.06.2008 alongwith the reply submitted vide letter dt. 30.01.2021 but the same was not on the letter head of the issuing authority. The institution submitted another LUC signed by the Tehsildar on 22.06.2009 alongwith the reply dt.06.08.2021 but the same also not on the letter head of the issuing authority. The institution submitted doubtful and different LUCs at different times.
- 4. The Website of the institute is not updated with the information prescribed under para 8(6), 8(14) and 10(3) of NCTE Regulations, 2014.

Hence, the Committee decided to withdraw the recognition granted to Sri Ankala Reddy Memorial College of Education, Alagadda – 518543, Kurnool District, Andhra Pradesh for conducting B.Ed. & M.Ed. programme with effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above".

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Sri Ankala Reddy Memorial College of Education, Alagadda** – **518543, Kurnool District, Andhra Pradesh** for conducting **B.Ed.** Programme of two years duration with an annual intake of 150 for three basic units of 50 students each with effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as

a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
