WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely, Sri Venkateswara College of Education, Plot No. 126, Pedda Setty Palli Village & Post, Proddatur Taluk, Kadapa District, Andhra Pradesh-516360 run by Medha Sree Educational & Development Society, Plot No. 5/1775, Sree Ramanagar, Proddatur Village, Post & Taluka, Kadapa District, Andhra Pradesh-516360 for D.E.Ed. & D.E.Ed.-AI course as per following details: -

- (i) Vide order no. F.No.SRCAPP1135/D.E.Ed./AP/2012/44906 dt. 02.08.2012 for conducting D.E.Ed. course of two-years duration with an annual intake of 50 students from the academic session 2012-2013.
- (ii) Vide order No. F.SRO/SRCAPP3418/D.E.Ed.-AI/AP/2016/84786 dt. 02.05.2016 for conducting D.E.Ed. -AI programme of two years duration with two units of 50 students each from the academic sessions 2016-2017.

2. **AND WHEREAS**, the institution has submitted written representation dt. 15.07.2022 stating that:-

"With reference to the subject cited above I wish to inform you that the management of Sri Venkateswara College of Education, D.Ed. - SRCAPP3418 would like to close of the college due to the non-Availability of admissions in D.Ed. Course.

In this connection the management of college also resolved that the college closed due the Non Availability of Admissions and proposed to the Director of School Education, as letter has sent to the Directors office for issuing of NOC with all relevant documents like NOC form the staff Members, resolution of the Executive committee, Xerox copy of NCTE Recognition, Affiliation copy and Xerox copies of the Endowment, Reserve fund FRDs Etc. dated 25.08.2021 wide ref1.

The Director of School Education requested the Principal Govt DIET Rayachoty that the submission of detailed report Dated 01.12.2021 wide ref2.

The Principal of DIET Rayachoty submitted his detailed report to the Director of School Education Andhra Pradesh on 12.05.2022 wide ref3.

Further I bring to your notice that the Director School Education, AP. took a long time i.e., from 25.08.2021 to till date still he has not issued NOC.

Now I think that there is no use of NOC as per the resolutions made by screening committee of SRC NCTE wide ref4. In this juncture I have submitted a declaration in the place of NOC from affiliating body as per the resolutions of surviving committee of SRC NCTE.

So, I request you to kindly issued the NOC to us for encashment of both Endowment and reserve fund. This is for your kind perusal."

3. **AND WHEREAS**, the SRC in its 413th Meeting held on 22nd & 23rd August, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made were made: -

The Committee noted that the institution has not filled Performance Appraisal Report (PAR)

The Committee agreed to close down the institution as requested by the Institution vide letter dated 15.07.2022 by withdrawing the recognition granted to **Sri Venkateswara College of Education, Plot/Khasara No.126, Peddasettipalli Village & Post, Proddatur Taluk & City, Kadapa District – 516360, Andhra Pradesh** for conducting D.El.Ed, D.El.Ed-AI Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in its earlier meeting."

4. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution by withdrawing recognition granted to **Sri Venkateswara College of Education, Plot/Khasara No.126, Peddasettipalli Village & Post, Proddatur Taluk & City, Kadapa District – 516360, Andhra Pradesh** run by Medha Sree Educational & Development Society, Plot No. 5/1775, Sree Ramanagar, Proddatur Village, Post & Taluka, Kadapa District, Andhra Pradesh-516360 for conducting D.El.Ed. & D.El.Ed.-AI programme of two years duration with an annual intake of 50 students (1 basic unit) + 50 students (1 basic unit) with effect from the academic session i.e., 2022-2023 onwards.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
