WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely, Kodanda Ramaiah Memorial College of D.El., Survey no. 528 & 529, Plot No. 528, Ring Road Steet, Kothapalli Village & Post, Proddatur Taluk and City, Kadapa District, Andhra Pradesh-516360 run by Panchasheela Educational Society, No. 528, Akula Ramaiah Vidyannagar Road, Kothapalli Village & Post, Proddatur Taluk and City, Kadapa District, Andhra Pradesh-516360 for D.El.Ed. & D.El.Ed.-AI course as per following details: -

- (i) Vide order no. F.No.SRCAPP950/D.El.Ed./AP/2012/45128 dt. 13.08.2012 for conducting D.El.Ed. course of two-years duration with an annual intake of 50 students from the academic session 2012-2013.
- (ii) Vide order No. F.SRO/SRCAPP3049/D.El.Ed.-AI/AP/2016-17/84605 dt. 25.04.2016 for conducting D.El.Ed.-AI programme of two years duration with two units of 50 students each from the academic sessions 2016-2017.

2. **AND WHEREAS**, the institution has submitted a written representation dt. 13.07.2022 stating that: -

"The subject cited above I am submitting a few lines for your consideration and to take necessary action. The management of Kodanda Ramaiah Memorial College of D.El. decided and resolved unanimously to close the college due to non-availability of admissions into D.El. decided and resolved unanimously to close the college due to non-availability of admissions into D.El Course.

In this connection I had obtained NBOC from the Staff and NOC from the affiliating body i.e., The commissioner of School education, Andhra Pradesh as per the rules of NCTE. Now I enclosed NOC from affiliating body, NOC from the staff, resolution by Executive Committee of the Society, Affiliation Order and xerox copies of DFDR's both Endowment and Reserve Fund which are related to our college.

Hence, I request you sir, kindly issue the NOC for closing of College of and give permission to encashment of the DR's. The original FDR's were submitted in our office on 20.01.2015 as per wide reference 2. In this junction I humbly request you Sir, please kindly send the FDR's related our college for encashment form the bank."

3. **AND WHEREAS**, the SRC in its 413th Meeting held on 22nd & 23rd August, 2022 considered the matter and decided as under: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made were made: -

The Committee noted that the institution has not filled Performance Appraisal Report (PAR)

The Committee agreed to close down the institution as requested by the Institution vide letter dated 13.07.2022 by withdrawing the recognition granted to Kodanda Ramaiah Memorial college of D.Ed. Plot No. 528, 529, Ring Road, Kottapalli Village & Post, Proddatur Taluk & City, Kadapa District – 516360, Andhra Pradesh for conducting D.El.Ed, D.El.Ed-AI Programme under clause 17(1) of NCTE Act, 1993 from the academic session 2022-2023.

However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director as per the general resolution taken by the SRC in its earlier meeting."

4. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby agreed to close down the institution by withdrawing recognition granted to Kodanda Ramaiah Memorial college of D.Ed. Plot No. 528, 529, Ring Road, Kottapalli Village & Post, Proddatur Taluk & City, Kadapa District – 516360, Andhra Pradesh run by Panchasheela Educational Society, No. 528, Akula Ramaiah Vidyannagar Road, Kothapalli Village & Post, Proddatur Taluk and City, Kadapa District, Andhra Pradesh-516360 for conducting D.El.Ed. & D.El.Ed.-AI programme of two years duration with an annual intake of 50 students (1 basic unit) + 50 students (1 basic unit) with effect from the academic session i.e., 2022-2023 onwards.

5. Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

6. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
